DROPOSED AMENDMENT OF THE CON-STITUTION OF PENNS YLVANIA. Joint resolution Proposing an amend-ment to the Constitution of Pennsylva-hia.

Be it Resolved by the Senate and House of Rep-resontatives of the Commonwealth of Pennsylvania in General Assembly met, That the following amendment of the Constitution of this Commonwealth be proposed to the people for their adoption or rejection, pursuant to the provisions of the tenth article thereof, to wit :

AMENDMENT. Strike out the Sixth Section of the Sixth Ar-ticle of the Constitution, and insert in lieu there


