Railroad Officials, Business Men and Manufacturers Take Advantage of Meeting Arranged by Harrisburg Chamber of Commerce To-morrow

Many representative business men from Central and Southern Pennsylvania will attend the foreign trade conference to be held in Y. M. C. A. hall to-morrow under the auspices of the Harrisburg Chamber of Commerce.

Chambersburg will be represented by President M. C. Kennedy and other officials of the Cumberland Valley railroad.

A. B. Farquhar, of York, president of the A. B. Farquhar Company, Ltd., an exporter to South America for forty-five years, vice president of the Chamber of Commerce of the U. S. A.

G. H. Wanless, secretary of the Lancaster Chamber of Commerce, will head a delegation among which will be H. S. Williamson, R. E. Roder and William C. Bidlack.

Lebanon, Coatesville, Pottsville, Mechanicsburg, Bedford, Reading, Bellefonte, Mt. Union, Columbia, Mt. Joy, Elizabethtown, Downingtown and East Downingtown, Middletown, HERSHEY and Lock Haven will all be represented.

Ralph W. Cooke, of Pittsburgh, industrial agent of the Pennsylvania railroad lines west of Pittsburgh, and Special Agent John H. Whittaker, of Philadelphia, industrial agent for lines east of Pittsburgh, will be present.

John Barrett, director general of the Pan-American Union, will speak on "Pan-American Commerce; What It Really Means to Central Pennsylvania."

Dr. E. E. Pratt, chief of the bureau of foreign and domestic commerce of the United States department of commerce, will speak on "How the Department of Commerce Aids Exports and the Extension of Its Work."

"How Our New Branches in South America Will Aid in Extending Foreign Trade," is the subject of a talk to be given by W. S. Kies, manager of the foreign department of the National City bank, of New York.

EXPLOSION IN POWDER MILLS

Workmen Had Inking of Disaster and 200 Hundred Fled to Safety

Chicago, Nov. 23.—Hundreds of windows in Gary were broken to-day by a nitroglycerin explosion in the works of the Aetna powder mills, four miles distant.

No one was killed or injured, it was reported, as a leak in an oil tank gave warning that an explosion might be expected and the workmen, numbering about 200, fled.

CHANGING THE BLANKS

IN CORPORATION REPORTS

Beneficial Changes for State and Corporation Are to Be Made by Auditor General Powell for the Next Year

Important changes, beneficial alike to the state and to the corporations affected, have been made in the forms of some of the blanks furnished to companies for the making of capital stock reports to the Auditor General.

The greatest differences are in the blanks for the use of manufacturing companies and of companies engaged in the transportation, telegraph, telephone or electric light business.

Changes already made were decided upon after the Auditor General had consulted with the officers of a number of corporations, with the accountants of the Interstate Commerce Commission and with the Federal income tax accountants.

They make reporting to the Auditor General an easy matter for companies which have arranged their bookkeeping to meet the accounting standards of the Federal officers.

Further, the new forms are so devised as to dovetail with the standard of the Pennsylvania Public Service Commission.

One entirely new form of capital stock report blank has been introduced this year. It is to be used by distilling and brewing companies and follows almost exactly the form of the blank for manufacturing corporations, except that it does not provide for a petition for exemption under the act of June 8, 1897.

Get Auto Licenses Now "Do your Christmas shopping early but first send to the State Highway Department at Harrisburg for your 1915 auto licenses," is what is asked by the department.

According to a statement issued by the Automobile Division of the State Highway Department to-day, license plates will be sent out by parcel post. The Federal Postoffice Department has not yet been able to devise any means of preventing congestion of the mail around the holiday season and for this reason it is advisable that applicants for licenses act promptly.

License plates applied for now will be shipped to the holders prior to December 10 and by this means delay will be avoided.

The Automobile Division has received more than 4,000 applications for next year's licenses up to the present time. Inasmuch as the law explicitly states that the license tags for the current year expire at midnight on December 31, wise owners and operators of automobiles and motorcycles are giving attention to the hint given several weeks ago that those who were tardy in applying would not escape the penalty of the law this year.

It is expected that more than 150,000 applications of all classes will be received for next year. In anticipation of the rush for applications the Automobile Division has prepared to handle next year's applications promptly.

ASK MORE TIME TO PLEAD New Haven Directors Undecided How to Enter Final Pleadings

New York, Nov. 23.—The twenty-one directors and former directors of the New York, New Haven and Hartford Railroad Company, under indictment on charges of violating the Sherman anti-trust law, had not decided to-day how they wanted to enter their final pleadings. The single exception was Thomas DeWitt Cuyler, of Philadelphia. William Rockefeller and the other men under indictment so announced through counsel in appearing in the Federal Court for final pleadings on this, the last day which has been given them.

Their request that they be given until to-morrow to make up their minds was granted.

Mr. Cuyler entered a plea in bar of prosecution, claiming immunity on the ground that on February 7, 1913, in the capacity of director of the New York, New Haven and Hartford Railroad Company, he appeared as a witness before the Federal Grand Jury of this district which was then investigating an alleged violation of the Sherman law.

James Edwards, a Virginia negro, bound for Chicago, "just decided to hop off" when he arrived in Harrisburg and he "hopped" into the tailor shop of L. S. Shandler. He also "hopped out with a pair of trousers. He got three months.

He Stole a Cornet For stealing a cornet and a watch, Andrew Strickler, employed in a Market street lunch room, got four months. As an excuse for walking out of his boarding place with his roommate's overcoat and shoes, John Smith, 19 years old, a Southerner, said: "I'd bin drinking." He was given seven months.

When the choir of Wesley A. M. E. church decided to give a concert in Carlisle several weeks ago, Stauley Jackson, one of the members, was figuring on a scheme by which to get carfare to that city. He pawned a \$25 overcoat belonging to William B. Luckett, his roommate, for seventy-five cents. Jackson said he thought Luckett wouldn't miss the coat since he had two. Jackson got three months.

Edward Bradley struck Grace Van Buskirk in the face "because she cussed me" and got thirty days. A similar sentence was imposed on Oliver Curtis, who confessed to striking Susie Willis.

"She tore my shirt and I soaked her," he said.

JACOB FAHS FATALLY HURT

Native of Pennsylvania Fell From Load of Wood in Kansas

Jacob Fahs, who was born in Lancaster county, Pa., in 1838, died last Tuesday, Holton, Kan., from the effects of injuries he received in falling from a load of wood a few days previous. While driving along a country road the wagon went over a little ditch, throwing Mr. Fahs off. He struck on his face and a sack of corn upon which he was sitting struck him on the back of the head, rendering him unconscious. His injuries consisted of concussion of the brain, a broken collarbone and rib and internal injuries. He died without regaining consciousness.

His son, William, and wife, of Illinois; a sister, Mrs. F. J. Keller, and husband, of this city, and a nephew, Ed Fahs, of Abilene, Kansas, reached Holton Sunday evening and were present at the time of Mr. Fahs' death and burial. He was buried in Holton cemetery nine days ago, and was in the garden and held in high esteem by all who knew him.

TELLS COURT HIS EARNING CAPACITY IS \$10 A MONTH

Defendant in Non-Maintenance Case Says \$1.25 a Week Is All He Can Pay His Wife—Ordered to Give Her \$1.50 Weekly

"Until my sister-in-law came into our home everything went lovely. I don't think we could have lived happier even if my husband had been wealthy," said Lila Wise, the wife of Harvey Wise, when she appeared before Judge Kunkel this morning and asked for a maintenance order against her husband in favor of herself and their two small children.

"Who is this woman to whom you refer?" asked the Court.

"It is Emma Rhan. She and my husband disappeared on the same day several months ago, and they were seen together in Cleveland, Ohio. They also were seen in Carlisle and in Hagers-town, Md."

The woman added that the separation between her and her husband followed quarrels growing out of Wise going to the Rhan home, presumably to play cards. The Court directed Wise to pay \$6 a week for the support of his family. The Sheriff informed the Court that the Cumberland county authorities have lodged a detainer against Wise, in connection with a suit brought by Mrs. Wise, in which the husband is wanted on a serious charge.

Gives Him Another Chance Since his marriage two years ago, Willis Lehr, his wife said, has been in jail more than eighteen months. The jail appeared against him in a non-support suit but said she would give him "one more chance to reform" and the suit was withdrawn. Similar action was taken in a case in which Lehr was charged with defrauding his boarding house keeper. He was released upon his promising to pay all claims against him, including the costs.

"His sister and his mother wanted to boss me and I left," said Mary, the wife of Earl Dalton, when she appeared against her husband in a non-maintenance suit. The defendant said his monthly earning capacity is \$10.

"What do you think you can pay your wife?" asked the Judge.

"Oh, about \$1.25 a week," he replied.

"That wouldn't keep the chickens," added the Judge. Dalton was directed to pay his wife \$1.50 a week.

Charles Snyder, of Pillow, this county, brought up on a non-support charge, said he needed his wages, \$13 a week, all for paying his board and buying "other stuff I needed." He had nothing left for his wife and child, he said. The defendant told a story to the effect that the "good times" he had had were financed by his friends. On being questioned further he admitted inaccuracies in his story.

Advised to Tell the Truth "How much can you spare your wife?" the Judge asked.

"About \$4 a week," he said.

The man was directed to pay Mrs. Snyder \$22 a month. The Court adding:

"And when you are brought before us again, tell the truth."

For the support of his wife and child, Clyde Hopple was directed to pay \$4 a week. Luther Yngst was ordered to pay \$3.50 a week for the maintenance of his wife and three children.

WOMAN DOCTOR TO CARE FOR HOMELESS BELGIAN CHILDREN

Chicago, Nov. 23.—Dr. Caroline Hedger, formerly in charge of the infant welfare work in Chicago, and her assistant, Miss Janet Hall, will leave to-morrow for Belgium to take charge of the work of caring for homeless children under the Belgian Red Cross.

The Chicago Women's Club to-day donated \$2,000 to Dr. Hedger and her assistant to defray their expenses. They will carry 10,000 doses of typhoid vaccine, prepared and donated by a Chicago woman physician at a cost of \$5,000. In New York Dr. Hedger will be given 10,000 vaccine needles and \$700 worth of dressing by the Red Cross.

CHILE WILL STOP NEUTRALITY BREACHES, EVEN AT WAR COST

Lima, Peru, Nov. 23.—It is declared here to-day on what would appear to be good authority that the Germans have been maintaining what is described as a naval station outside of Valparaiso, Chile. Here they brought together a number of vessels having on board coal and provisions.

Chilean papers reaching here say the government is determined to stop these breaches of neutrality even at the cost of war.

20 KILLED IN BOMBARDMENT OF LIBAU BY GERMAN SHELLS

London, Nov. 23, 444 A. M.—According to Libau newspapers, during the German bombardment of Libau last Tuesday 700 shells were thrown in four hours, says the Petrograd correspondent of "The Times."

"Twenty people were killed and 40 others were injured, most of whom were women and children. No panic occurred and only that portion of the town within the zone reached by the guns was evacuated. In the other districts the people continued at their work as usual."

CENTRAL COMES OFF PERCH

Rescinds Order Concerning the Honoring of Mileage Books

Washington, Nov. 23.—Notice given by the New York Central lines that mileage books sold before October 1, when the rate was raised, from two cents a mile to two and a quarter, would not be honored for passage, has been withdrawn.

Although the railroad proposed to redeem the unused portions of such books, the Interstate Commerce Commission suspended its regulation, holding it was a violation of the contract of purchase. To-day the railroad withdrew the regulation and the commission vacated its order of suspension.

WOMAN'S BODY IDENTIFIED

Was Stewardess of Steamer Lost in Storm on the Lakes

Duluth, Minn., Nov. 23.—The woman whose body was found on the shore between Grand Marais and White Fish point Saturday, and who wore a locket with the initials "R. B." engraved on it is Rose V. Busick, of Buffalo, N. Y., according to W. A. McWatty, of this city.

McWatty says she was stewardess of the steamer Curtis, which was lost in the storm with her two barges.

LATE WAR NEWS SUMMARY

Informations had postponed the decision.

Germany accounts the battle in Russian Poland as virtually won, and is already estimating the effect upon future military operations. An announcement to-day from the German general staff is to the effect that a decision is at hand and that conditions everywhere are favorable from its point of view.

In Berlin it is said the outcome of the main battle with the Russians may decide not only that phase of the main battle, but with the whole European struggle. A decisive triumph in the east, it is pointed out, would free part of the German army engaged there to assist the forces which are facing the British, French and Belgians in the west.

Upon what information the confident Berlin predictions were based was not fully apparent. An official German statement to-day said merely that the fighting in Poland continues. Russia admits that the Germans have won partial successes, but there is nothing to show that the continued German advance toward Warsaw is influencing the Russian campaign to the north, in eastern Prussia, or to the south near Cracow, Galicia.

Unofficial reports from Petrograd state that the Russians are continuing their advance in east Prussia and have captured Gumbinnen, a fortified city 66 miles from Koenigsberg. According to all accounts, the main battle, between the Vistula and Warta rivers, is still in progress and, although the Germans are pressing forward steadily, the Russian army is still offering determined resistance.

In the west the fighting in Belgium, which has been slow for several days on account of the weather, has broken out with renewed ferocity at Ypres, with the artillery playing the main part. London suggests that this may be the prelude to another German attempt to pierce the line, as in the past onslaughts by German infantry have been preceded by heavy artillery attacks.

From the other fields of battle reports were meagre. The Turks were said to have reached the Suez canal after defeating British forces.

The British steamer La Correntina, missing for several weeks after she sailed from Buenos Aires for Liverpool, is now said to have been sunk by the German converted cruiser Kronprinz Wilhelm. Her crew having been taken by a German steamer to Montevideo. The French bark Union, it is said, also was sunk by the Kronprinz Wilhelm.

ROCKEFELLER FOUNDATION RELIEF WILL START AT ONCE

London, Nov. 23, 2:36 P. M.—The relief work of the Rockefeller Foundation in Austria, Serbia, France and some sections of Russia will be undertaken actively at once. Dr. Wickfield Rose, head of the Rockefeller commission, said to-day that he and his associates would soon visit these countries, where the needs of the people are perhaps as great as in Belgium, although less has been heard of the conditions there.

It is the purpose of the Rockefeller committee, Dr. Rose explained, to discover the localities in which the needs of the people are greatest, regardless of the country, and send immediate relief. Ambassador Page and Dr. Rose have learned that the conditions are especially bad in some sections of Serbia.

PALMER SPENT \$2,526.17

Of That Amount \$1,715 Was Contributed by the Various Friends of the Defeated Senatorial Candidate

Friends of A. Mitchell Palmer, defeated Democratic candidate for United States Senator, contributed \$1,715 toward his campaign expense, according to his expense account filed in the State Department to-day. Of this amount W. A. Dickson gave \$500; C. H. Dickerman, \$100; E. Passmore, \$250; Grant Dibert, \$150; Cornelius Haggerty, Jr., \$250; J. F. McGovern, \$100; Charles F. Jenkins, \$100. The rest of the \$1,715 was made up of smaller contributions.

Mr. Palmer spent \$2,526.17, making up the excess out of his own pocket. His money was spent, according to the itemized statement, for clerk hire, telegrams, expressage, hotel, postage, printing, advertising and traveling expenses. The items are all small. He has no unpaid bills, everything, so far as he is personally concerned, being paid.

Theodore C. Lamb, Pittsburgh, treasurer of the Personal Liberty Party Finance Committee, received \$726.22 from the German American Alliance and spent it all for clerk hire, traveling and advertising.

It is believed the expense accounts of the Republican, Democratic and Washington Party State Committees will not be filed until just before the time expires for filing on December 3. At the various headquarters the accounts are now being made up slowly, the delay being accounted for by the difficulty in getting back the vouchers showing the expenditures.

Mr. Palmer is the only candidate for Senator who has filed an account here to-day refused to issue a writ of error to bring to the United States Supreme Court for review the conviction of Leo M. Frank for the murder of Mary Phagan, a factory girl, in Atlanta, Ga., in 1913.

Frank is under sentence of death. His attorneys applied to Justice Lamar for the writ on the ground that a right under the Federal Constitution had been denied him when the jury's verdict was returned during his absence from the court room.

William Looser Receives High Honor

W. L. Looser, a well known attorney of Harrisburg, has just been appointed a member of the Supreme Forum of the Supreme Lodge of the World Loyal Order of Moose. This Forum is the highest Court of Appeals of the Order. The Moose has over six hundred thousand members in the order and have lodges in all parts of the United States and Canada as well as in Australia and South Africa. Harrisburg has a lodge of nearly three thousand members. Philadelphia lodge's membership amounts to more than nineteen thousand members in its lodge.

President's Visit to His Daughter

ASKS GERMANS TO TABOO HOSTILE NATIONS' GOODS

Continued From First Page.

San Francisco, Nov. 23.—Baron E. H. Von Schack, imperial German consul, urged Germans throughout America to boycott goods manufactured by nations hostile to their country, in an address last night at a benefit for German wounded soldiers, widows and orphans.

"The allies," he said, "always envious of Germany's present occasion, have utilized the present occasion to slander German industry. With cold-blooded contempt of all commercial treaties and of their own laws, they are suppressing German commercial houses within their own countries and are annulling, or plainly stealing, German or Austrian patents of invention."

"Here in the United States are twelve million Germans or German-Americans. Placing the buying capacity of these at only \$150 per annum, their yearly purchasing power is \$1,800,000,000."

"Let me suggest a better system of buying. You should buy articles of German or Austrian origin if you cannot obtain American-made wares. Before buying ask where the article was made. Be loyal to America and loyal to your Fatherland."

BERLIN PAPERS HOPEFUL OVER OUTCOME IN POLAND

Berlin, Nov. 23, via The Hague and London, 11:10 A. M.—All the Berlin newspapers comment favorably this morning and very hopefully on the possible outcome of the fighting in Poland. They express the opinion that these engagements may decide the entire Russian campaign, if not the outcome of the war.

The "Lokal Anzeiger," has published an interview with an officer who speaks for the military authorities. He says that in consequence of the rolling up of the Russian right wing by General Von Hindenburg and the simultaneous attack of the Austrians on the Russian left, a general Russian retreat with the evacuation of Lemberg is only a question of time. In their previous attack, this officer says, the enemy operated in accordance with their program but to-day they have been forced to give up their war plans and face an entirely different situation. Existing conditions were foreseen by the German and Austrian commanders. According to the same authority the Russians lack artillery and rifles.
