To the Editors of the Review-Sirs:-1 see by your issue of Monday, in speaking of the case of the Commonwealth vs. VANN and FERGUSON, for burning the barn of GUY SMITH, you censure the jury because they found the defendants not guilty, but ordered them to pay the costs, and you then proceed to condemn such verdicts as being wholly wrong in principle. A few moments consideration will show the folly of any such conclusion. The legislature in its wisdom saw fit to confer this power upon juries, whenever in a misdemeanor the defendant is acquitted, costs can be put upon the prosecutor, the county or the defendant. In order to convict, the proof must convince beyond any reasonable doubt. Many cases are tried where the weight of testimony is against the defendant, and yet the jury in their mercy think there may be a reasonable doubt, while all of them have good reason to believe him guilty. In such case should the prosecutor be visited with the costs, or the county? If the first, then any man would be deterred from prosecuting, unless he was assured he could prove guilt, without any knowledge of what might be set up for a defense. This would, in effect, be a premium for crime, and if we take the second proposition as the rule in such case, the weight of taxes would soon be so enormous that property owners could hardly bear the burden. On the whole, such a verdict as was rendered in the case mentioned, was, and is often a just one, and meets out to the parties substantial justice.
