The News Condensed.

The Pennsylvania tramp law has been found to work very effectively.

A home is soon to be opened by some women in Brooklyn to help repentant female ex-convicts.

The Friendly Sons of St. Patrick, of New York subscribed \$2,500 for the relief of the Irish sufferers.

Senator Davis, of West Virginia, is reported to be the wealthiest man in his State.

Four stores and the Wagner House on Jacob, near Main street, Penn Yan, N. Y., were burned yesterday.

The Board of Pardons has agreed to meet on the 27th inst., to consider the riot bill bribery cases.

The jury in the Bucholz case at Bridgeport, Conn, failed to agree and were discharged.

Mr. John A. Bingham, Minister to Japan, will be a candidate for renomination to Congress in his old district.

"Brick" Pomeroy's Democrat, at La Crosse, Wis., has been sold to Alexander Nevins, who will make it a Republican evening newspaper.

The oldest graduate of the College of New Jersey is John A. Cuthbert, of Alabama. He was graduated in 1805, and, although now more than ninety years of age, is still practicing law in Mobile.

The delegates to the Methodist Protestant Conference, now in session, together with their ladies, were received by the President and Mrs. Hayes yesterday afternoon.

The canvassers of the Chicago Times have now ascertained the opinions of 9,281 Republicans in Illinois, of whom 5,282 are for Blaine, 2,935 for Grant, and 1,064 for Washburne.

One hundred masked men broke into the jail at Winchester, Ill., early yesterday morning, opened the cell of Joseph J. Field, and shot him. He was convicted of murder.

It is announced that Captain William B. Hart will be appointed chief clerk of the State Treasury under Treasurer Butler, Mr. Chris. Mangle, of Pittsburg, having the place of cashier.

The Senate has passed a bill, at the special instance of Mr. Bayard, removing the political disabilities of Roger A. Pryor. General Pryor is one of the last of the erring brethren to resume his place as a citizen.

It is reported that the friends of Senator Ferry of Michigan will urge him at Chicago as the Republican candidate for Vice-President on the ground of his party fealty and of his experience as presiding officer of the United States Senate.

John M. Palmer, of Illinois, one of the founders in that State of the Republican party, has formally announced himself as a candidate for the Democratic nomination for President on the platform of State Sovereignty. The world does move—and the wrong way sometimes.

Methodists Church of Canada has forty-four missions among the Indians of the Northwest Territory, thirty missionaries, ten native assistants, and thirty-one hundred and fifteen members. Between Puget Sound and Alaska there are six Methodist missionaries and a number of teachers among the Indians.

A dangerous \$20 United States Treasury note has made its appearance in Chi-

cago. It is of the series of 1875, letter P, and is printed on imitation fibre paper. The shading under the words "United States" is darker than in the genuine note but the general appearance of the bill is excellent.
