The News Condensed.

Mrs. Tyler, the widow of the ex-President, is now living quietly at Georgetown. She is a devoted Roman Catholic.

The steamer "City of Mexico," with General Grant and party on board, arrived in Galveston safely shortly after noon yesterday. There was general rejoicing over the news.

Representative Phelps has introduced a bill providing for the free passage of Irish emigrants on the return voyage of the ship Constellation, now about to start to Ireland with provisions for the suffering peasantry of that island.

The Greenbackers met in State Convention in Harrisburg yesterday. Hor. W. C. Plummer, of Crawford county, was chosen temporary chairman, and F. W. Hughes, permanent President. Without transacting much business the convention adjourned until evening.

The case will probably be taken to the United States Supreme Court, Ironers Ca. General B. Butler having announced his willingness to manage the case there, for the opponents of the Chinese.

The Albany Evening Journal celebrated its fiftieth anniversary Monday, by inviting the veteran journalist Thurlow Weed, its founder, to the editorial chair long enough to introduce it to the second half century of its existence-which all will wish, as do we, may be as prosperous and influential for the right as the first half has been.

The majority report of the Senate Committee on Privileges and Elections in favor of giving Mr. Kellogg's seat to Mr. Spofford, was presented yesterday. Senator Hoar presented the minority report, denouncing the proposed outrage as a erime to be classed with the firing on Fort Sumter. Senator Keilogg delivered a scathing speech charging Mr. Hill with making false statements.

A bill was introduced by Mr. Kirkwood in the Senate to enable the Commissioner of Agriculture to test the practicability of manufacturing sugar on a large scale from sorgham and sugar cane.

The House committee on Ways and Means has decided to report favorably the bill reducing the duty on bi-chromate or potash from four to two cents per pound, and to place chrome iron ore apon the tree list.

Representative Shallenberger, of this state has secured the passage of the Senate bill relative to the international exhibition of sheep, wool and wool products, to be held in the Centennial buildings at Philadelphia in September, under the auspices of the Pennsylvania Agricultural Society. The bill allows the importation free of duty, of all articles intended solely for exhibition on the occasion named. It directs the Commissioner of Agriculture to attend the exhibi, ion in person, and to make a full report upon it. The success of the exhibition is believed by its promoters to be already assured. Japan, Canada, and New South Wales and other parts of Australia will be creditably rapresented.
