Tioga county is rapidly coming to the front rank in the raising of tobacco. About \$20,000 worth was shipped from the Tioga valley station recently, and there is still some unsold. Messrs. Wells and Allen, the purchasers, speak in high terms of the quality of the tobacco raised in this vicinity, and the prices received are considerably in advance of those paid at Big Flats, Chemung and adjoining localities. The attention of our farmers will be largely turned in this direction the coming season, as it has been practically demonstrated that tobacco is the most profitable crop that can be raised here.—Mansfield Advertiser.

Quite an interesting case from Smithfield was argued before Judge McCOLLUM last week. At the last township election there were three school directors to be chosen, two for a full term and one to fill a vacancy. Five candidates were voted for, and the election board gave certificates to the three receiving the highest number of votes, designating CYRILIUS FORREST for the short term, he having received the smallest vote of the three, but more than either of the other two candidates. Some seventy-five votes were cast for "C. B. RIGGS, short term," and that gentleman claimed the certificate on the ground that he had received a majority of the votes cast for the short term, and brought the case to court. He was represented by FRICK & OVERTON. R. A. MERCUR appeared for FORREST. After argument the Court ordered the proceedings quashed. The controversy has excited a good deal of interest in the township, and has arrayed nearly every voter in Smithfield on one side or the other. Politics do not divide the parties, but it is alleged that the graded school at the Centre is too expensive. We believe the contestants do not intend to abandon the case, but will commence new proceedings.
