It has been a long time since the borough was free from debt and we join with the Treasurer in commending the wise and prudent administration of the borough government for the past few years, which has led to a result so earnestly desired by every tax-payer. With moderate

taxation and a continuance of the prudent policy displayed of late years, the borough can be kept out of debt in the future, while the streets and side walks may be kept in repair and all necessary improvements prosecuted. Let the watch-word hereafter be "Keep out of debt."

In according "honor to whom honor is due," in connection with the management of the finances, Treasurer and Clerk KINGSBURY and Collector WICKHAM are entitled to special mention. Their duties have been faithfully, honestly and promptly performed.

The Presbyterian church was dedicated this afternoon, the Rev. Doctor Stewart of Towanda, preaching an interesting sermon. Rev. C. C. Corss of Smithfield, Rev. Henry Welles of Kingston, Rev. Resolved, That we present to Mr. McGlathery our hearty thanks for the zeal he has shown as a parish priest in his care for this church, believing as we do that the present harmony in the congregation, and the increase of churchly interest and devotion are largely due to his teachings and ministrations during the five years of his rectorship.

Resolved, That we offer Mr. McGlathery our heartfelt sympathy in his broken health, with the sincere desire and prayer that he may speedily be restored to vigor and future usefulness.

Resolved, That a copy of these resolutions be presented to Rev. Mr. McGlathery and be spread upon the parish records.

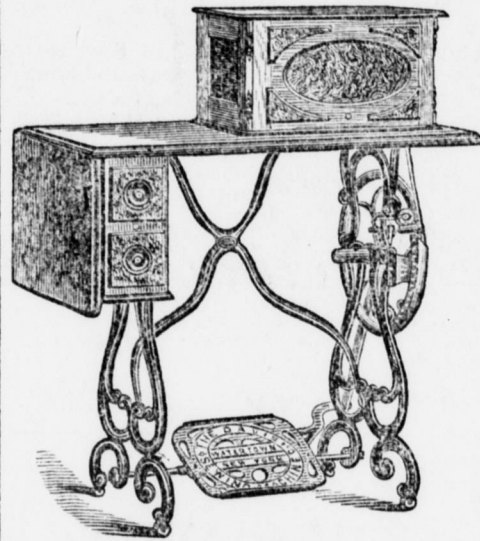
