Elizabeth Martin, of Brooklyn, was found dead in her rooms on Monday of smallpox. Her husband was removed to the smallpox hospital some days ago, and since then the neighbors have shunned her. She died alone, in great agony.

Mr. and Mrs. Roswell P. Flower, of New York, have given St. Thomas Episcopal church \$35,000 for building a St. Thomas home, and \$5,000 for a perpetual fund for charitable purposes, in memory of their only son who died recently.

The burning of the Court house at De Kalb, Kemper county, Miss., last month destroyed all the papers in connection with the trial of the alleged assassins of Judge Chisholm.—This practically ends the prosecution. It is stated that one of the Gullys is suspected of setting the building on fire.

Jerome J. Hinds, an old mail contractor, is gaining considerable unenviable notoriety by an attempt to besmirch certain officials in the Post Office Department, especially the Second Assistant P. M. General, by charging frand and corruption in the allotting of contracts. We don't believe a word of his statement; for, although we do not know Gen. Brady, we do know that the Auditor for the Post Office, who approves the bills would not countenance any fraud in his office.

The Cleveland Herald, by authority of Mr. Hayes, makes a statement concerning his salary and savings as follows: "The aggregate of his salary for the four years was \$200,000. The expenses of the position during that time were \$134,000. Had Congress refunded the \$4,000 he paid for the expenses of the 'visiting statesmen' to Louisiana his savings would have been about \$70,000. As it is, he went out of office with \$56,000 to be carried from his account as President to the benefit of his account as a private citizen. When he became President he was burdened with debts to the amount of \$90,000, mostly on account of bequests charged he has paid \$60,000 out of his savings from the Presidential salary, so that the net available results in cash of his Presidential term is \$6,000."


