We find the following in the Elmira Advertiser of yesterday, but inquiry among the colored people here fails to confirm the strange story so far as it relates to this place:

A peculiar case came before the Recorder yesterday forenoon. It seems that a black woman who used to live in Elmira, with a man named John Roy, now lives in Towanda and has for years, with a man whose name is not known. She was married to Roy, who yet lives in this city. Mrs. Roy, as that is her legal name, has a daughter aged thirteen, besides several other children. A short time ago Mrs. Roy came to Elmira to settle up some business left by the death of a relative. This thirteen year old daughter was left at home in Towanda. John Roy claims that he is her father, and while the mother was here in Elmira, he skipped down to Towanda and brought back with him the tender representative of his own flesh and blood. Yesterday forenoon the whole crowd appeared before the Recorder to have the dispute settled, but His Honor made short work of it. The child acknowledged that she greatly preferred liv-

ing with her father, and the Recorder said, "Then go home with him." In the afternoon Mrs. Roy again appeared in the court to see if she could not get a habeas corpus. She said the child was not Roy's, but the other man's—and by way of corroboration said—"She wasn't born until more than a year after we parted, and every woman ought to know who the father of her children is." The Recorder blushed a little and said that was correct—she ought, but His Honor could do nothing to help her recover her child, and referred her to the County Judge for anything in the habeas corpus line. As she left the room Bijah French remarked that perhaps the way to settle the matter was to do as old king Solomon recommended, "cut it in two and give both half." Then the mother did get mad, and flashed a look at the suggester of such a cold blooded arbitration that sent him for refuge behind Bijah Kelly, and followed it with the voluntary clincher—"No sah, John Roy shan't have even a piece of what he has not helped pay for." After she retired the court and the officers entered into a statistical discussion and came to the conclusion that a boy will have cost his father one thousand dollars when he has reached his tenth year, and a girl fifteen hundred, and that if John Roy comes to his brevet wife's terms, he will have to squander about \$1700 to hold peaceable possession of the unfortunate progeny that has caused such an unhappy litigation. At last accounts the habeas corpus had not been served.
