Believing that the companies will enforce the curtailment plan for regulating prices we believe that it would be better for both the companies and the public if this was rigidly impressed upon the public mind by a literal enforcement of the restriction immediately. There will be a large amount of coal required this year, and if the public waits too long, it will certainly have to pay very much higher
