In the equity suit of HARRIS et al vs. ASA PACKER's exrs. et al, Judge MORROW, appointed Hon. SAMUEL LINN, of Williamsport, Master and Examiner. He came on Saturday and will begin at 2 o'clock to-day to take testimony. It is said the case involves large sums, and the evidence will be voluminous. The parties have secured the services of Mr. TUPPER, court stenographer, to take the evidence. The intention is to have it written out in long-hand and printed each day, so that the Master, parties and counsel will have it in convenient form for reference.

It is not known to many of our people that Judge LINN was formerly a resident of our county, but such is the fact. He came from Bellefonte here in the year 1836 at the age of sixteen, and was an engineer on the North Branch Canal under his uncle, Mr. HARRIS, who was chief engineer. He remained here till some time in the year 1839, and has often been heard to say that they were the "three happiest years of his life." It is certain deep and pleasant impressions were made upon his mind, for he not only remembers events, but the names of persons from Brownstown to Athens, their business and peculiarities. He thinks he knew every man, woman and child along the line of the canal between those two points. Aside from the hard work he had to do, it is not claimed but that he enjoyed fun, and that his happiness in this respect was not circumscribed. It was the jubilant, jolly overflow not unexpected in a young man of his ability, and sound bodily condition. And now after 42 years of "hard knocks" in practical life, he returns to us in the maturity of manhood, but inclined to feel young again and live over the merry days of '36-9. Many of his friends and acquaintances are gone 'tis true, but many remain who will extend to him warm hands and cordial greetings, and make his sojourn among us as pleasant as possible.

After he left our county, he read law at Carlisle, was admitted to the bar in 1843, practiced his profession at Bellefonte until 1858, when he was elected President Judge of the district composed of Clinton, Center, and Clearfield. After serving out nearly his term, he resigned and about twelve years ago came to Williamsport, where his practice has been large and lucrative. He is one of the ablest lawyers of the state. The parties to the equity suit are fortunate to have a Master so able and upright as Judge LINN is.

#### The News Condensed.

It is reported that Judge Tyner is to go as a Minister to Turkey. It is thought that Frank Hutton, of Burlington, Iowa, will succeed him as First Assistant Postmaster General.

It is thought in Washington that the Republican Senatorial caucus, to be held to-morrow, will determine to go into executive session and consider the uncontented and important nominations.

Secretary Blaine being asked in regard to his feelings toward Mexico, said that he felt very kindly towards her, and approved or would assist every effort to extend a reciprocal trade between the two Republics.

Bradstreet's record of the failures during the past week in the United States and Canada, show a decrease, the number being only 91, against 106 the previous week. They are generally small, and do not effect the general trade of the country.

A special dispatch from St. Petersburg, received in Paris by an indirect route,

declares that the Anitischoff and winter palaces are being surrounded with defences similar to those used to defend iron-clads against torpedoes.

Under the Tweed Ring the ferry franchises held by the Union Ferry Company in New York, were sold for ten years for one dollar per year. The city has since recovered \$300,000 from the Company, and on Thursday the franchises were sold for nearly \$140,000 a year.
