SCHOOL DIRECTOR'S CONVENTION .- The tri-ennial convention of school directers of Bradford county for the purpose of electing a County Superintendent of public schools for the coming three year assembled in the Court House yesterday. At o'clock. Supt. RYAN called the convention to order. On motion of J. B. HINDS. Dr. O.H. ROCKWELL of Monroeton was elected President. On Wanted, A Good Girl who can cook, wash taking the chair the President made a very neat and appropriate speech. C. W. REY-NOLDS of Pike, and J. F. BLOCHER of Wyalusing were elected secretaries on motion of E. A. THOMSON.

On motion of Senator ROCKWELL of Troy Borough, seconded by J. E. PIOLLET of FITCH has opened his ice cream parlors and Wysox, G. W. RYAN was nominated for County Superintendent. On taking a ballot one hundred and seventy one directors answered to the roll call, all of whom voted for Mr. RYAN, and he was declared unanimously elected.


