### The News Condensed.

The Senate held an executive session yesterday.

A Valparaiso dispatch says that a Chilean protectorate over Peru is rumored. A treaty of peace is doubtful.

A great Socialist Congress is to be held in London on the 14th of July. The object is to organize a revolutionary movement throughout the world.

The United States Court decided in the case of Payne, the Oklahoma leader, that the lands which the latter seeks to colonize, are not open to settlement.

There is trouble at Dartmouth College, the faculty, students and alumni being arrayed against President Bartlett. Nearly all the faculty desire his resignation.

At a meeting of Payne's followers at Wichita, Kan., resolutions were adopted urging that Payne renew his effort to effect a lodgement in the Indian Territory.

In New York, a son of Mosher, the abductor of Charley Ross, was captured in an attempted burglary, Monday night. When cornered he threatened to kill the officer with his revolver.

At Grenada, Miss., while Captain Fowler, a druggist, was charging a soda fountain, Monday, the generator exploded, killing Dr. Ray, a leading physician, and fatally wounding Fowler.
