D. preached a very interesting and instructive sermon, from the account of the disciples' fruitless fishing excursion, which was so gloriously changed when Christ appeared and bade them cast the net once more on the right side of the ship. At the close of the sermon he presented the subject of endowing the Lewisburg University, and announced that the work for that object in Bradford Association is delegated to Rev. C. T. HALLOWELL. A collection was

taken for Mrs. THOMAS SHEATDOWN, amounting to \$40.

An address on the work and needs of the American Baptist Publication Society was then given by Rev. C. W. RAY. At 2 p. m. there was a session for business lasting one hour. During this a resolution thanking the Bradford county commissioners for closing the county house against visitors on the Sabbath was unanimously passed. At 3 o'clock a meeting of the Ladies Missionary Society was held under the direction of Mrs. LARK BIRD. At 3:30 a sermon on the words "Jesus Christ, the same yesterday, to-day and forever," was preached by Rev. WM. ENTWISTLE of the Columbia and Wells church.

Another item of business deserves public mention. A vote was passed to devote a full page of the minutes to an obituary notice of the late O. N. WORDEN, the facts to be furnished by Rev. THOS. MITCHELL and R. M. WELLES, the compiling to be done by Rev. C. T. HALLOWELL.

In the evening a sermon on the words "Earnestly contending for the faith once delivered to the saints," was preached by Rev. S. F. MATTHEWS, followed by one-half hour of free conference.

THURSDAY MORNING.

After business, a sermon from the words "There they crucified him," was preached by Rev. C. A. RAYMOND of West Franklin, after which an hour of free conference and it was a glorious dessert after a good feast.

Resolved, That we heartily approve and endorse the administration of President Garfield.

Resolved, That we approve of the course of our Senators and Representatives in the Legislature during its past session.

The Chairman was authorized to appoint an executive committee of nine members and a treasurer. A committee was also appointed to report to the next county convention on the advisability of changing the basis of representation in County Convention.
