### Republican County Convention.

Pursuant to a resolution passed by the Republican County Committee in session Friday June 24, 1881, the Convention of the Republican party for 1881 will convene at the COURT HOUSE in TOW-ANDA BOROUGH on TUESDAY, SEPTEMBER 6, at ONE O'CLOCK, P. M., to make the following nominations for county officers, to wit:

One person for Sheriff.

One person for Prothonotary, &c.

One person for Register and Recorder, &c.

One person for Treasurer.

Two persons for County Commissioners.

Two persous for County Auditors.

And for the transaction of any other business that may come before the convention.

The Committees of Vigilance of the several election districts will call primary meetings at the usual places of holding Delegate elections for their respective districts, for SATURDAY, SEPTEMBER 3D., 1881, to elect by BALLOT two delegates to represent each district in said county convention.

The delegate elections in the BOROUGHS will be organized at SIX O'CLOCK, P. M., and be kept open continuously, to close at 8 o'clock, p. m. In the districts of Barclay, North Towanda and Athens District No. 3, from FIVE O'CLOCK, P. M .. continuously until 7 o'clock p. m., at which time they shall close. And in all other townships from THREE o'clock, p. m., continuously until FIVE o'clock, p. m., at which time they shall close. The votes shall then be counted and the result eertified by the proper officers of said meetings to the Chairman of said Convention and a copy delivered at once to the delegates elect.

The Committees of Vigilance are particularly requested to give at least three weeks' written or printed notice of the said primary elections, end to carefully observe the above rules in conducting the said primary meetingr.

It must be exceedingly gratifying to all true and loyal citizens to see the universal solicitude shown in the welfare of the President, by all classes irrespective of political creed or sectional strife since the attempt to assassinate the good man. It has brought to the surface strong ties of general brotherhood and a natural feeling of common national interest heretofore hidden deep under partisan strife and sectional hatred. The announcement of the diabolical act, had no sooner gone forth on the electric wires, than indignation and sorrow were expressed throughout the land and messages of con dolence forwarded to the wounded man and sympathy given his respected family. And the South, supposed to take little stock in the Chief Magistrate, only as compelled to submit to his rule by the strong arm of the law, has nobly come to the front, given succor to the nation and exhibited a deep anxiety in the painful situation that much atones for its past hatred and disloyalty. It has been a dangerous channel to pass through, to feel the pulse of the nation in a paralyzing crisis, but out of the diagnosis comes the gratifying report that we are a united people, healthy at heart and prepared for ordeals and calamities that would throw into a general panic if not produce anar-

chy in any other nation in the world. The fact is we have a good and wise President and the masses know it. He was guiding the Ship of State majestically along, meeting with remarkable tact and sagacity the adverse winds, keeping off the shoals of corruption, commanding the helm himself, not submitting to those of the crew who would usurp his power and direct the course contrary to his own revised and safe chart. We also notice with pride that a day of fasting and prayer has been appointed by Kentucky and Arkansas-States lately in rebellion and which at the President's election gave large majorities against him.

Hon. Joseph E. Brown, of Georgia, in conversation with Postmaster General Leroy-Robt McKee, Wesley Wilcox, Leroy James recently related an incident which may have an important bearing in determining the question of motive in Guiteau's crime. He said that having occasion to visit the State Department, May 17, in company with a friend, they met two men coming out, one of whom he subsequently identified from his photograph, to be Guiteau. The speaker's language and manners attracted Mr. Brown's attention, and he thought at the time that vengence of some kind was meant against the Secretary of State.
