Republican County Convention.

Pursuant to a resolution passed by the Republican County Committee in session Friday June 24, 1881, the Convention of the Republican party for 1881 will convene at the COURT HOUSE in TOW-ANDA BOROUGH on TUESDAY, SEPTEMBER 6, at ONE O'CLOCK, P. M., to make the following nominations for county officers, to wit:

One person for Sheriff.

One person for Prothonotary, &c.

One person for Register and Recorder, &c.

One person for Treasurer.

Two persons for County Commissioners.

Two persous for County Auditors.

And for the transaction of any other business that may come before the convention.

The Committees of Vigilance of the several election districts will call primary meetings at the usual places of holding Delegate elections for their respective districts, for SATURDAY, SEPTEMBER 3D., 1881, to elect by BALLOT two delegates to represent each district in said county convention.

The delegate elections in the BOROUGHS will be organized at SIX O'CLOCK, P. M., and be kept open continuously, to close at 8 o'clock, p. m. In the districts of Barclay, North Towarda and Athens District No. 3, from FIVE O'CLOCK, P. M .. continuously until 7 o'clock p. m., at which time they shall close. And in all other townships from THREE o'clock, p. m., continuously until FIVE o'clock, p. m., at which time they shall close. The votes shall then be counted and the result eertified by the proper officers of said meetings to the Chairman of said Convention and a copy delivered at once to the delegates elect.

The Committees of Vigilance are particularly requested to give at least three weeks' written or printed notice of the said primary elections, end to carefully observe the above rules in conducting the aid primary meetingr.

Recreation.

It is gratifying to observe a growing tendancy on the part of the American people to provide themselves with recreation, seasons of rest from toil, both physical and mental. The fashionable resort does not afford the kind of relief necessary. Men, and women too, are coming to recognize the fact that the world is in a great degree what we choose to make it. Our own condition of thought and soul has more to do with the enjoyment we are seeking than local habitation. If all things serve it is pleasant and profitable to travel for a holiday. If this is not possible, or is difficult, the man or woman who can say "My mind to me a kingdom is" may be as absolute a monarch at home as abroad. Summer leisure and winter work are enjoyable to the disposition which regards all men charitably. The foibles of mankind are not of consequence enough to provoke a wise man's displeasure, and he is especially foolish who permits human follies to and the flies; and so may all discover that real happiness lies in seeking it in ourselves. We shall so find by the instinct of self-preservation if we reflect that, while others appear obnoxious to ourselves, we may be so to them in the same, or to a greater degree. Nothing to do, and knowing how to do it, is the secret of rest, limited to no place or condition, and better as an occasional mood than as a habit.

The New York Herald still holds to the opinion expressed on July 9, that President Garfield is "suffering from an exagerated and erroneous diagnosis" and a consequently erroneous and exagerated line of treatment, and wants Dr. Agnew to tell some one why a strong man with a wound that has not penetrated any great cavity, not injured any great blood vessel, nor touched any vital organ-with a mere flesh wound in the wall of the body-is now, after 37 days, no further advanced toward recovery than Mr. Garfield is?

The New York Commercial Advertiser urges that unless the present postage stamp flirtation, in which a particular position of the stamp expresses a particular sentiment, and by which the postoffice employes are given extra work and trouble, cease, the reassertion of the stamped envelope plan and the suppression of all postal stamps under the grade of twentyfive cents should take place.
