Baily and Wolfe.

General Silas M. Baily the Republican candidate for State Treasurer, whom Mr. Wolfe is so vindictively anxious to defeat is one of those "hundreds of thousands of the noblest heroes." The "independent" candidate, who was a valiant home guard when men were wanted at the front, endeavored to throw a doubt on General Baily's soldier record by stating that he had "nothing to say" about it. It is highly probable that the old soldiers of the State and the patriotic people thereof, who are honest, consistent and true to the principles and pledges of the Republican party, will remember General Baily's record and reward him by their votes and elect him State Treasurer.

That Mr. Wolfe is arrogant and audacious in character, we have abundant evidence furnished by himself. Mr. Wolfe raises the standard of revolt against the alleged domination of "bosses"—yet his whole political career is the record of a persistent struggle waged for the attainment of the dictatorship of the Republican party of Pennsylvania. More than any other man he is responsible for the continuance of the discreditable Senatorial deadlock at Harrisburg last winter, in which his shibboleth was "rule or ruin." Failing then in the full accomplishment of his purpose, he went into the State convention to renew the struggle for supremacy, and again defeated, he resorted to the desperate ultimatum of revolt against the party, and under the specious cry of "reform" appeals to Republicans to sacrifice principle, honor, good faith and all that true men hold dear, and follow him in his crusade for the overthrow of the glorious old Republican party of Pennsylvania and the triumph of the enemy with which it has been battling for twenty years. That a sufficient number of Republicans to accomplish Mr. Wolfe's purpose can be beguiled into thus stultifying themselves seems incredible.—Allegheny Mail.

Chicago grain speculators have struck a snag. On Monday last wheat had reached the very high rate of \$1.43. On Saturday it had gone down to \$1.35, and corn had followed suit—passing from 76 cents to 63. Pork also felt the pressure, falling 40 cents during the week. One firm collapsed with 12,000,00 bushels of corn on its hands. Grain was at once shipped East to Buffalo in large quantities, with the result of a material decline in prices. Corn fell 2 1/2 cents on October options and November contracts went off 2 1/2 and 3 cents lower. Other produce sympathized and men's souls were tried the small operators feeling very much as if they had fallen into dens of thieves and bears or had been gored by bulls. But no one will care a moment for their losses or their grief. They who play with fire must expect to be burned. The latest reports, as is invariably the case, in short crop years, are very reviving. Bradstreet reports as follows: Yield of wheat in the Western States, 248,127,000; Southern States, 40,000,000; Middle States, 34,500,000; Pacific coast, 33,825,000; Colorado and Territories, 12,000,000; New England, 1,000,000; total, 368,962,000 bushels; against 480,000,000 bushels, showing a loss of 111,038,000 bushels. The yield of the corn crop in Western States, 769,241,000; Southern States, 247,000,000; Middle States, 62,400,000; New England States, 7,000,000; Territories, 5,000,000; Pacific coast, 2,500,000; total, 1,163,641,000, against 1,500,000 last year.

An oil well just opened near Greensburg, Westmoreland county, yields twenty-five barrels a day.

The Lehigh coal and navigation company will pay its first dividend for several years in November.

The full measure of Conkling's injury to his party by resigning his seat is now manifest in the election of a Democratic Vice President.

A suit has begun at Quebec against A. H. Murphy, Member of Parliament, for \$150,000, alleged penalty for sitting in the legislative assembly without the proper legal qualifications.

Two of the Iron Mountain train robbers who were confined in the penitentiary at Little Rock have confessed. Their names are Samuel and Thomas Williams. They were formerly printers in St. Augustine, Fla., and were out of money and plundered the train for funds to get married on.

The Philadelphia Times says: "It is yet too soon to present anything like a safe estimate of Wolfe's vote in this city, but, if his cause shall continue to progress as it has progressed during the last week, he will be likely to receive more than 20,000 votes in Philadelphia, and 40,000 is not beyond the range of possibility. If the vote were to be taken tomorrow, Baily would receive about 50,000, Noble about 50,000 and Wolfe about 20,000."
