THE ENCAMPMENT-While the soldiers' encampment in East Towarda was not so lhrgely attended either by the boys in blue or spectators, Commander AMMERMAN and his efficient adjutant, C. T. HINTON, deserve great credit for the thoroughness with which they planned the arrangements and the precision with which they were executed. The weather was disagreeable and cold rain fell almost continuously, but the several hundred veterans who had assembled did not permit these untoward ciecumstauces to interfere

with the objects of their gathering-keeping alive the memories of the war, and re-kindling the fires of patriotism in their own hearts.

Despite the rain the sham battle yesterday afternoon was witnessed by a large crowd composed of ladies and gentlemen. The contending forces were placed in battle array at 2:30 p.m. The Union army was under command of Gen. AMMERMAN, assisted by Gen. AINTON, while Gen. WILMOT, aided by Gen. WOODIN, led the "rebels." The consummate skill and good generalship displayed in the combat afforded the best evidence that the science of war has not been forgotten.

It is farther directed that the election polls of the several districts shall be opened at seven o'clock in the morning, and shall continue open without any interuption until seven o'clock in the evening when the polts shall be closed.

No person shall be qualified to serve as an election officer who shall hold, or within two months have held, any office, or appartment, or employ.

have held, any office, or appartment, or employment in or under the Government of the United States, or of this State, or of any city or county, or of any municipal board, commissioner of trust, in any city, save only Justices of the Peace and Aldermen, notaries public and persons of militia service of the State; in a shall any election of the state; in a shall any election. of the State; nor shall any election officer be eligible to day office to be filled at an election at which he shad serve, save only to such subordinate municipal or local offices below the grade of city or county offices, or shad be designated by general law.

At the opening of the polls at all elections, it shall be the duty of the Judges of Election, for their re-

be the duty of the Judges of Election, for their respective districts to designate one of the inspectors, whose duty it shall be to have in custody the registry of voters, and to make the enteries thereof required by law, and it shall be the duty of the said inspectors to receive and number the ballots presented at said election.

All elections by the citizens shall be by ballot, and evy ballot voted shall be numbered in the order in which it is received, and the number recorded by the cierks on the list of voters opposite of the name of the elector from whom received. And every voter voting two or more tickets, the several by the cierks on the list of voters opposite of the name of the elector from whom received. And every voter voting two or more tickets, the several tickets so voted shall each be numbered with the number corresponding with the number to the name of the voter. Any elector may write his name upon his ticket, or cause the same to be written thereon and attested by a citizen of the district. In addittion to the oath now prescribed by law to be taken and subscribed by election officers, they shall severally be sworn or affirmed not to disclose how any elector shall rave voted unless required to do so in a judicial proceeding.

One ticket shall embrace the names of all the Judges of Court voted for, and to be labeled outside "Judiciary." One ticket shall embrace all the names of State officers voted for, and be labeled "State." One ticket shall embrace the names of all County officers voted for, including office of Senator and Members of Congress if voted for, and be labeled "County."

All judges living within twelve miles of the Prothonotary's office, or within twenty four miles; if their residence be in a town, village or city, upon the line of a railroad leading to the County seat, before 2 o'clock past meridian of the day after the election, and all other Judges shall, before twelve o'clock meridian of the second day after the election, deliver the returns together with return sheet to Prothonotary of the Court of Common Pleas of the County, which said return shall be filed' and the day and hour of filing marked thereon, and shall be preserved by the Prothonotary for public inspection.
