One of the happiest suggestions in connection with the erection of an enduring memorial to the late President Garfield was contained a week or two ago in a letter to the *New York Evening Post* by Willie and Tottie Herrick, two small children of Newport, R. I. It was that a home be erected somewhere in the country for the sick and infirm children of the whole nation, and the little ones in their communication inclosed 25 cents each as the beginning of the fund. Since then the idea has taken root. *St. Nicholas*, the most popular of children's magazines has embraced it. We can conceive of no more beautiful and touching tribute to James A. Garfield, the affectionate son and loving father, than this, and will gladly do all in our power to promote it. The publishers of *St. Nicholas* (the Century Company) will be the custodians of the proposed fund, the plan of which will be further explained in the next number of that periodical.

No man in Bradford county has rendered more valuable service to the people than Hon. James H. Webb, and it was commendable in his party to recognize this fact in his nomination for the office of Register and Recorder—an office in which the people are more directly interested than any other in the county, or at least that class who most need the assistance and counsel of just such a man as Mr. Webb. His capacity for the responsible duties of the position are well known and his reputation for strict integrity is above suspicion. He was fairly nominated by the dominant party and will receive the support of all fair-minded Republicans.

It is as true in politics as in religion, says the *Chicago Times*, that the blood of the martyrs is the seed of the Church. Since the cause of civil-service reform has its martyr it is destined to sweep onward rapidly toward the goal of triumph hereafter the stars in their courses will fight for it. Political parties will vie with each other in demanding that the business of the Government be conducted on business principles. Spoils organs dare no longer oppose the proposition lest they be overwhelmed with public scorn.
