It is farther directed that the election polls of the several districts shall be opened at seven o'clock in the morning, and shall continue open without any interuption until seven o'clock in the evening when the polls shall be closed.

No person shall be qualified to serve as an election officer who shall hold, or within two months have held, any office, or appartment, or employment in or under the Government of the United States, or of this State, er of any city or county, or of any municipal board, commissioner of trust, in any city, save only Justices of the Peace and Aldermen, notaries public and persons of militia service of the State; nor shall any election officer be eligible to any office to be filled at an elections at which he shall serve, save only to such subordinate municipal or local offices below the grade of city or county offices, or shall be designated by general law.

At the opening of the polls at all elections, it shall be the duty of the Judges of Election, for their respective districts to designate one of the inspectors, whose duty it shall be to have in custody the registry of voters, and to make the enteries thereof required by law, and it shall be the duty of the said inspectors to receive and number the ballots presented at said election.

All elections by the citizens shall be by ballot, and every ballot voted shall be numbered in the order in which it is received, and the number recorded by the clerks on the list of voters opposite of the name of the elector from whom received. And every voter voting two or more tickets, the several tickets so voted shall each be numbered with the number corresponding with the number to the name of the elector from whom received. And every voter voting two

All judges living within twelve miles of the Prothonotary's office, or within twenty four miles; if their residence be in a town, village or city, upon the line of a railroad leading to the County seat, before 2 o'clock past meridian of the day after the election, and all other Judges shall, before twelve o'clock meridian of the second day after the election, deliver the returns together with return sheet to Prothonotary of the Court of Common Pleas of the County, which said return shall be filed, and the day and hour of filing marked thereon, and shall be preserved by the Prothonotary for public inspecbe preserved by the Prothonotary for public inspec-
