PITTSBURGH GENERAL MARKET.

The Commercial of the 5th inst. says, The week closes upon a quiet market there being but little activity to-day in any branch of trade, excepting flour, for which staple there continues considerable of a demand. This demand, however, is mostly confined to home consumption. The demand for other articles is of a very limited character, and only to satisfy the present wants of customers. There is however, in most branches of trade, a good feeling prevailing, and confidence in the future is gaining ground. As to the time when trade will open, there is a diversity of opinion. Some do not look for it before Spring, while others expect it in a few weeks. Merchants everywhere are exploring the necessity which compels the closing of Iron, Glass and other manufacturing establishments, and hope that some arrangement will be effected for their continuing in operation. If they close, a good many merchants will also close shop, which they will not have to do if the mills continue to run.
