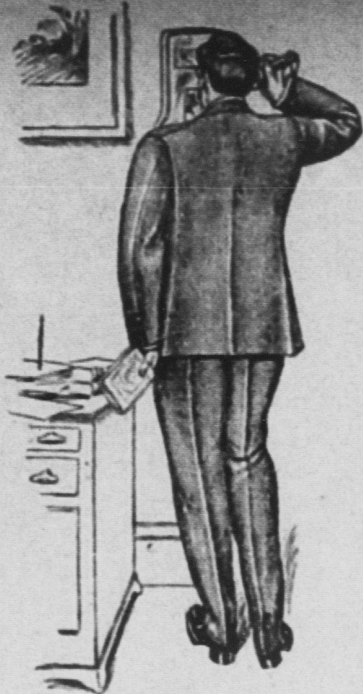

**WOMAN GRABBER
A SAYRE CITIZEN**

Conference of Police Authorities Results in Determining Identity of Man Who Has Been Terrorizing the Women Up at Waverly

At a conference held last night between the Waverly and Sayre police officers the identity of the individual in black who has been persistently annoying women in the New York state town was definitely determined. For some time past a full grown man, dressed entirely in black has been terrorizing women who were compelled to pass over the Pennsylvania avenue bridge after the shades of evening had fallen. Complaints were entered to the Waverly police and they at once set out to apprehend the man. The bridge was watched and some nights ago Officer Gridley discovered a man on the bridge, but when the officer approached him he fled. A night or two afterward the same man, who was described as being six feet tall and wearing a heavy dark moustache, was chased over the Spaulding street bridge by a man residing in the neighborhood. The fellow made his escape, however, and since then has not been seen.

The people have become so agitated over the matter that the officers determined to ascertain who the man was, and they are confident that they have succeeded. According to descriptions furnished the police department by residents of Waverly and members of the police force the man is believed to be a resident of Sayre. In fact the police authorities are sure of this and from now on the man's movements will be watched night and day. The man is thought to be suffering from dementia and as soon as sufficient evidence is obtained by the police he will be arrested and his mental condition inquired into, provided he is not shot by the irate citizens of Waverly who declare that unless he discontinues the practice of annoying women they will do something desperate.

HEARING ADJOURNED

A petition signed by a large number of taxpayers has been presented to county commissioners McKinney, Harkness and McNulty asking that the fees of the county treasurer's office be fixed at a sum not exceeding \$1,500. The commissioners and auditors held a meeting yesterday and the question was discussed, but no action was taken as it was thought proper to wait until the next treasurer was elected and sworn in so that he might have opportunity to present his side of the case. Accordingly, the meeting was adjourned until November 9th.

**MARRIED WOMAN
THE COMPLAINANT**

Charges a Sayre Young Man With Being the Author of Her Misfortune - Defendant Held for Further Hearing

John McCann, a young man employed by the Lehigh Valley as a hostler in the round house, was held in Justice Murray's court this morning in the sum of \$300 bail for a further hearing on a complaint entered by Mrs. Anna Geiss, wife of John Geiss, a Lehigh Valley fireman. Mrs. Geiss charges McCann with being the author of her trouble. Last night she appeared before Justice Murray and made a statement which resulted in a warrant being issued for McCann's arrest.

In August last the woman, who is not yet out of her teens, avers that she was married to John Geiss, but her present condition was brought about previous to her entering into the matrimonial state.

McCann was arrested this morning by Chief Walsh and immediately taken before Justice Murray. He was represented by Hon. L. T. Hoyt who entered a plea of not guilty and demanded a hearing, which was set for Wednesday next at 10 a. m. Attorney C. C. Vocum appeared in behalf of Mrs. Geiss.

On account of the complainant being a married woman the circumstances surrounding the case are most unusual ones, and as there are several fine legal points involved, the outcome will be awaited with interest.

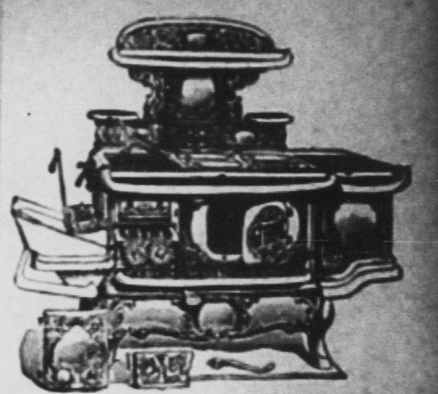
