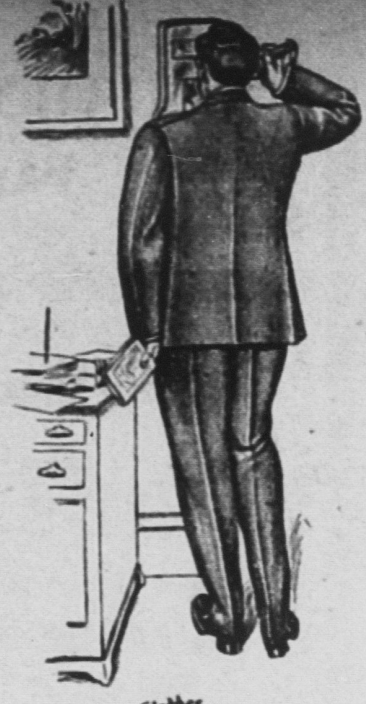

**"PA HAS WENT AND  
SHOT HIMSELF!"**

Startling Announcement Made by a Young Girl at the Lehigh Station Yesterday Afternoon

"Pa has went and shot himself" was the thrilling though ungrammatical exclamation that emanated from the lips of a young girl, barely out of short skirts, at the Lehigh Valley station yesterday afternoon, as she rushed up to an elderly woman who was seated in one of the seats in the ladies' waiting room along side a young man some years her junior. The exclamation of the girl caused considerable consternation among others seated about the room and it also appeared to upset the plans of the elderly woman, and her male companion. It appears that the two had purchased tickets for Boston, and were waiting for a northbound Lehigh train, but when the girl announced that "pa had went and shot himself" there was a scurrying of feet and the trio left the station. This morning the woman appeared at the ticket window and the station agent gave her the money in return for the tickets to Boston. In the meantime it was learned that the elderly woman and her husband had indulged in a little domestic infelicity and the woman declared that she would leave her lord and master and go to Boston, the Hub of the Universe and there in the excitement of a great city try and forget her tribulations and woes. The husband, when he learned that his wife was about to depart, and in company with another man, announced his determination to go to the woodshed and blow his brains out. He told this confidentially to his daughter and she it was who rushed into the depot waiting room and startled everyone there by announcing that "pa had went and shot himself."

The fact that no cases of suicide have been reported to the proper authorities, and the further fact that the woman reconsidered her determination to go to Boston, it is quite likely that "pa" has also done some reconsidering and is still in the land of the living.

**TO INSTALL PRIVATE  
LIGHTING PLANT**

Water Company Will Light the Pumping Station With Its Own Electricity

The Sayre Water company is making preparations to install a private lighting plant at the pumping station. The contract will be let within a few days and it is expected to have the plant in operation before winter has fully set in. The plant will be large enough to furnish power necessary to run 25 incandescent lights, and as the company has an over-plus of steam the latter will be used instead of oil or gasoline.

**SAYS HE STOLE  
PRINTERS' FUNDS**

Former Towandian Gives Himself Up to Philadelphia Police After Failing to End His Life

Henry M. Allen, a former resident of Towanda, but who recently has been holding a situation in the government printing office at Washington, surrendered to the Philadelphia police Saturday, confessing that he embezzled the sum of \$2,200 from the Printers' Benevolent Association of Washington, of which he was the treasurer and secretary and begged to be locked up.

Allen disappeared from his home in Washington on Wednesday last, since which time his relatives have been looking for him. He left a note to his wife stating that he intended to go to Abington, Montgomery county, and end his life. Allen was born near the place that he had selected to end his career, and after being locked up he stated that he went to a grove near Abington and swallowed a quantity of laudanum, but instead of the drug killing him it sickened and made him drowsy. He claims that after coming out of the stupor he wandered to Philadelphia, and debated for a long time whether he should again attempt self destruction or give himself up. He chose the latter course and went to the police and told them of his having embezzled the printers' funds. When arrested Allen did not explain to the police what he had done with the money which he confesses to having taken. He was penniless when taken in custody.

Nearly all of Allen's relatives live at Towanda. He secured an appointment in the government office some years ago and at once became decidedly popular among the printers.

**FUNNY FRANK DESHON**

Frank Deshon, the well known comic opera comedian, in a magnificent production of the successful musical piece, "The Office Boy," will come to the Loomis on Friday night. "The Office Boy" was one of the popular plays of last year and has so far been seen principally in the east and New York city, where it played for three months last winter. It is in two acts; the first one representing the office of a firm of New York divorce lawyers, and the second showing the grounds of a country villa with a private race course in the distance. Mr. Deshon, as a four dollar-a-week office boy, who is compelled in spite of himself, to become a jockey and ride a spirited race horse named "Greased Lightning," is said to be irresistibly funny. The libretto of the piece is by Harry B. Smith and the musical score by Ludwig Englander. A large and capable company is said to support the star.

**SALARY OF THE  
COUNTY TREASURER**

Proposition to Slash the Fees of This Office in Half is a Rank Injustice to the Treasurer-elect.

The present county commissioners and auditors have decided to take no action in the matter of fixing the county treasurer's fees so that they will not exceed \$1,500 per year. Two meetings were held and at the last one it was determined that it was a matter which should properly come before the commissioners and auditors who are to take office on the first of January next. Like disposition was made of the petition that the county prisoners be boarded at the rate of 25 cents per day. The new commissioners and auditors will probably not be compelled to adjust the latter proposition as the sheriff-elect, Job Griffin, has promised to charge no more than the rate demanded in the petition which was presented by F. N. Moore, who poses as the representative of the Bradford County Tax Payers' Association. Mr. Moore is also behind the movement to fix the treasurer's fees. At the present time the treasurer is entitled to 7 1/2 mills for every dollar of county funds that he handles. Taking into consideration the amount of responsibility involved in handling these funds the rate would seem to be low enough, but Mr. Moore in behalf of his petitioners, contends that the fees should be cut in half. Granting an assumption that the treasurer under the present rate is paid too much for his services, there is absolutely no justice in the contention that the fees should be slashed in two. The office of treasurer is a highly important one. The incumbent is compelled to bond himself in a satisfactory sum for the faithful performance of his duties. Mr. Waters, the treasurer-elect, entered the contest believing that the present fees would not be disturbed. His canvass involved the expenditure of considerable money, and in asking for the office he had a right, to expect that the emoluments would not be disturbed, or at least that they would not be cut to a beggarly basis. If the commissioners who take office the first of January next wish to act in the matter let them fix the rate for the term which is to commence three years hence, then the candidate, whoever he may be, will enter the canvass knowing exactly how much he is to receive for his services. If this suggestion is not feasible let them at least use reason in reducing the amount. The present intention, if carried out, is a rank injustice to the treasurer-elect, and is not by any means endorsed by the heavy tax-payers who believe that the man who handles the county's money should be paid a respectable salary.
