DILLON HAD TO TELL

Counsel For Fugitive Krup Gives Bondsman's Name.

HOTEL MAN PUT UP FORFEITED \$5,000

Story Current That Missing Floater Agreed to Plead Guilty and Take His Medicine For \$5,000, but Through Fear Skipped Out.

NEW YORK, Nov. 22.—District Attorney Jerome now knows the name of the man who furnished the \$5,000 cash bail that enabled Krup, the floater, to escape from the jurisdiction of the criminal branch of the supreme court here a few hours before his case was called for trial.

The name was revealed to the grand jury by Charles P. Dillon, Krup's counsel, who turned the money over to George Simpson. Simpson deposited it with the city chamberlain. Dillon gave the important information only after he had been taken before Recorder Goddard and instructed to answer every question put to him rather than risk imprisonment. When the grand jury adjourned Dillon was taken to the office of Assistant District Attorney Sanford, where he was questioned at length about the bail transaction. John J. Murphy, Alderman Gaffney and some other prominent politicians of the Eighteenth assembly district will testify in the grand jury inquiry into the Krup case.

John Newman, a wealthy contractor, was one of the witnesses subpoenaed. He went on the original bond for Krup for \$1,000. He was not called to the grand jury room, but told the reporters that it was not he who put up the \$5,000.

There is a story current that Krup had agreed to plead guilty and "take his medicine" under agreement that he should be paid \$5,000 upon his release and that every effort would be made to secure him a pardon. But, the story goes, Krup got cold feet as soon as he attained his liberty on bail and instead of showing up for trial as he promised he skipped.

It has been learned that the man who put up the \$5,000 cash bail for Krup was John F. Pickett, a saloon keeper of 281 Third avenue. Pickett has been subpoenaed by Attorney General Mayer to appear before the grand jury today. Through him the authorities hope to learn who is the Krup man higher up.

Justice Davy in the criminal branch of the supreme court sentenced the first of the men arrested in connection with violations of the election law at the recent municipal election. The man sentenced is Edward Meade of 92 Barrow street. Meade pleaded guilty to having voted in the Fifth assembly district on the name of John F. Foley of 119 Waverly place after having voted on his own name. He was caught through making a mistake in the address of the real Foley, which is 119 Washington place. Meade was sentenced to prison for a period of not less than two years nor more than three years and six months. Meade was evidently staggered by the severe sentence.

Justice Giegerich, sitting in extraordinary special term of the supreme court, has signed five orders for the inspectors and poll clerks of five election districts to show cause before Justice Amend tomorrow why they should not reconvene and count the ballots voted in their respective districts on election day.

NEW YORK, Nov. 22.—"Graft" as a standard English word was indorsed by the delegates to the conference of the church federation in Carnegie hall, which was termed a general favorite, and it was the unanimous opinion that no other word would do to describe what was meant by it when used in a certain sense. Several delegates wanted the federation to eliminate it from resolutions which had been passed and to substitute the synonym "dishonesty," but the latter was voted down as not conveying in full the idea contained in "graft."

Denver Bank Cashier Held Up.
DENVER, Nov. 22.—Two masked men, armed with revolvers, forced Cashier Gabriel Jones of the South Denver bank, a small concern, to deliver to them \$2,000, all the cash in the safe, and fled in a buggy. A man and a woman who entered the bank while the robbers were there were able to stand with their faces to the wall and hands up.
