VOLUNTEER TO CONTRIBUTE SKIN

Twenty Lehigh Valley Railroad Men Will Each Sacrifice One Square Inch of Skin for the Benefit of Martin Galliger

Twenty Lehigh Valley railroad men have each volunteered to separate with one square inch of skin for the benefit of Martin Galliger, the conductor who was frightfully burned in the boiler explosion which occurred at Van Eitenville a few weeks ago. On Galliger's body there are twenty square inches of burned flesh which can only be healed with the skin grafting process. Recently Master Mechanic Kells visited the hospital and learned in order for Galliger to get well it would be necessary to secure the consent of some one to furnish the skin. Accordingly Mr. Kells said that he would volunteer as one. It was decided to ask for volunteers and with few exceptions the necessary number of men were secured who will submit to the surgeon's knife and when he has finished they will be minus one square inch of skin which will be grafted to the burned surface of Galliger's body. This process will be repeated until the entire burned section is covered. The work will not all be accomplished at once, however, but from time to time, as the patient is physically able to stand it.

FELL TWENTY FEET FRACTURED SKULL

Laceyville Man Seriously Though Not Fatally Injured While Engaged in Shingling a Barn

Ered Peet, a brother of Dr. Peet of Laceyville, fell from a barn which he was assisting in shingling yesterday and sustained a fracture of the skull. Peet fell a distance of twenty feet and landed on his head. The front of the skull was crushed in and for a time it was feared that he had sustained fatal injuries. He was brought to the Packer hospital last night, where the depressed bones in the skull were raised from the brain, and today it is thought that his chances for complete recovery is excellent.

FOUND UNCONSCIOUS ON LEHIGH BOX-CAR

At South Bethlehem last night an unknown man was found lying in an unconscious condition on the top of a Lehigh Valley box car. His face was covered with blood and a severe contusion on the upper lip and nose indicated that he had been struck with some blunt instrument. Several front teeth were loosened, and after being taken to the hospital it was ascertained that the injured man was suffering from concussion of the brain. He was well dressed but the appearance of his clothing gave the impression that he had been riding on the train for some distance. He is thought to have been a victim of tramps.

ICE MEN HAVE GIVEN UP HOPE

The ice men have about given up hope of harvesting a crop this year. In December they hoped for favorable weather in January, but now that January is nearly gone and the streams in this section are all open, dealers are beginning to give up all hope. Unless the weather man furnishes some frigid weather before the dawn of gentle spring, many dealers will probably erect artificial plants.

The funeral of Miss Stella Bosworth will be held from the Methodist church tomorrow afternoon at 2 o'clock. The Rev. J. F. Warner will officiate, and the remains will be taken to Tioga Point for interment.

TAKING EVIDENCE IN LICENSE CASE

Application of John Fletcher for License to Conduct a Hotel in Sayre Is Being Heard Before Attorney Paul Maynard Today

Evidence in the application of John Fletcher for a license to conduct a hotel on Lockhart street was taken before Attorney Paul Maynard at his office in the M. P. A. block today. The petitioner was represented by Attorney Maxwell of Towanda and H. H. Mercereau, Esq., of this place, while Attorneys Evans and Mercur appeared for the remonstrants. Six witnesses were sworn on each side. The purpose of taking the evidence is to ascertain if another hotel is really needed in Sayre. It was contended by the witnesses for the petitioner that travellers and transient people are compelled under existing conditions to go to Waverly in many instances for a night's lodging, there being no accommodations in this place. On the other hand evidence was presented by the remonstrants tending to show that Sayre at the present time contained all the hotels necessary to accommodate the public.

The evidence submitted before Attorney Maynard today will be presented to Judge Fanning and after he has examined the same, he will either grant or refuse the application.

LEHIGH IS MASTER OF THE SITUATION

In Complete Control of the Anthracite Field and Other Collieries Will Be Forced To Suspend

The Lehigh Valley is now the master of the situation in the anthracite field and in the future they shall say when the collieries shall work and when they shall not. This power was acquired through the recent Coxe deal, but at no time was it made more manifest than on Tuesday when the order was promulgated that work should be suspended for three days this week. At first nothing was thought of the suspension but when it dawned upon those employed at the individual operations that the Lehigh Valley was the only road which could furnish cars, matters assumed a different phase.

"PRINCESS BEGGAR"

In "Princess Beggar," the new comedy opera which the Messrs. Shubert will offer on Thursday, Feb. 1, at the Loomis, Miss Paula Edwards, the charming young star, will play the part of Elaine, daughter of a woodcutter, who saves the life of the crown prince of Vagarria, a mythical Teutonic kingdom. The prince naturally falls in love with his preserver and upsets the well laid plans of his royal father to dispose of his hand in marriage to the highest bidder, the royal exchequer being in a sadly depleted condition. "Princess Beggar" was written by Edw. Paulton, author of that most successful farce, "Niobe," and the music was composed by Alfred G. Robyn, whose melodious setting of "The Yankee Consul" was so well liked. The production is said to be uncommonly beautiful and costly, and the supporting company includes Eddie Garvie, Edward M. Favor, Stanley Forde, Robinson Newbold, Helen Marvin, Edith St. Clair, George Tenery, Guy B. Hoffman and others of prominence. The large and efficient chorus increases the total of the company to 80 people by actual count.

BUILDING AND LOAN ELECTED OFFICERS

Sayre B. & L. Association Held Meeting Last Night--Report Shows Excellent Condition

The regular annual meeting of the stockholders of the Sayre Building and Loan Association was held last evening at the office of the association, when the following officers were elected for the ensuing year: President, J. W. Bishop; vice president, W. T. Goodnow; Secretary, Charles C. West; treasurer, Wm. H. Flory; solicitor, H. F. Maynard; directors for 3 years, G. M. Angier, J. H. Price, Geo. L. Roberts; directors for 2 years, I. A. Samuels, Dr. Chas. Cummings, the last two to fill unexpired terms.

The twentieth annual report of the secretary was submitted and unanimously adopted. The report shows the association to be in a most excellent condition and to have done a large volume of business during the past year. The cash receipts amounted to \$81,011.45, nearly \$50,000 of which was loaned to stockholders for the purpose of purchasing homes in Sayre. It is not difficult to imagine what this means to the community. In addition to loans made, nearly \$7,000 was paid out on stock which matured during the year, and \$4,234 was drawn by free stock investors. The receipts last year exceed the previous year by \$10,000, and the assets have grown to \$227,623.67, an increase of nearly \$25,000 over the previous year. \$211,712 represent the amount of loans now standing against stockholders in the valley, this amount being invested in homes which are being paid for and nearly all of which are located in Sayre.

A glance at the report shows that a large series of stock will mature about April 1st, which will mean the distribution of \$30,000 among free shareholders alone.

CANDIDATE FOR BURGESS ON REPUBLICAN TICKET

Wm. Cross, Sayre's well known business man and citizen, has announced himself as a candidate for the office of chief burgess, subject to the rules of the Republican primaries which are to be held tomorrow evening. Mr. Cross is well known in Sayre as a citizen and business man. He has been highly successful in all his undertaking, has an energetic and forceful character, and should the Republicans see fit to nominate him and later elect him, the office of chief burgess would fall into capable hands. Thus far Mr. Cross is the only Republican who has come forward for the office.

ENGINEER MEETS HORRIBLE DEATH

Charles Hontz, a Lehigh Valley engineer, lost his life in a horrible manner on Tuesday. He fell from the tank of his engine to the tracks and was literally ground to pieces, the entire train passing over his body. The accident happened between Peters' crossing and Rockdale station. Why the engineer was on the tank is not known but is presumed that he went out for the purpose of ascertaining if the engine was in need of water. He was a resident of Packerton and was well liked by his fellow railroad men.

ATTORNEY EVANS FOR COUNCILMAN

Attorney I. N. Evans has announced himself a candidate on the Republican ticket for councilman in the fourth ward. Mr. Evans has represented the ward in the council before and his many friends are anxious to again see him a member of the borough law making body.
