An official inspection of the various branches of the Lehigh Valley system was made yesterday.

**JOHN A. WOODWORTH
DIED YESTERDAY**

He Was One of the Oldest and Most Respected Resident of This Section

John A. Woodworth, one of the oldest and most highly respected residents of this section, died at his home in "Wildwood" yesterday afternoon of cerebral apoplexy. Mr. Woodworth had been in ill health for the past six months having last summer suffered a stroke of apoplexy. A short time later he suffered a second stroke and yesterday afternoon a third caused his death.

The deceased was a native of Tioga county, N. Y., and was born 67 years ago. At an early age he removed from that county to the farm on the east side of the river a short distance north of Sayre. He was a farmer by occupation but found time to inform himself on current topics and was widely known as a man of broad information. Mr. Woodworth was a man of strict integrity and had a host of friends throughout this section by whom he was respected and admired. His death will remove a prominent figure. He was exceedingly interested in the welfare and growth of Sayre, and despite the fact that he was not a resident of the place, he always stood ready to advance the interests of this place and its citizens.

The deceased is survived by two sons, William, who resides on a farm near the family homestead; Arthur, a student at the University of Chicago, and three daughters, Ruth, Nancy and Laura all of whom reside at home.

The funeral will be held at his home in Wildwood, Sunday afternoon at two o'clock, the Rev. W. H. Sawtelle of Athens officiating. The remains will be taken to "The Rest" cemetery at Springs Corners for interment.

He was an elder in the Athens Presbyterian church and the other members of the session will act as bearers. The Masonic order of Waverly will have charge of the funeral at the grave.

**WOMAN ADMITS
STEALING DIAMOND**

Says That She Returned the Ring to Chief Walsh, but the Latter Denies Having Received It

In April last Charles Rogers, a well known citizen of Sayre, lost a valuable diamond ring. Where the gem went to he never knew. Today, however, he received a letter in a woman's handwriting, evidently disguised, in which the writer stated that she had stolen the diamond from Rogers' house on Desmond street. She also stated that she had sent the diamond to Chief of Police Walsh, with instructions to turn it over to his owner. When seen today Chief Walsh strenuously denied having received the gem, and after making an investigation of the circumstances surrounding the disappearance of the ring, and also reading the letter received by Mr. Rogers today he pronounced, the whole case a hoax. He says that the woman is playing some sort of a shrewd game but he is as yet unable to tell what it is.

MRS. JOHN R. WHITE

Mrs. John R. White of this place, died at the Packer hospital yesterday afternoon after a brief illness. She was admitted to the institution on Sunday last and on Wednesday underwent an operation. The deceased and her husband came to this place from Wilkes-Barre about a year ago and have since resided on Desmond street. She is survived by her husband, one daughter, Miss Julia White, and two sons, G. Sommers White, formerly a representative of the Scranton correspondence school at Sayre, and Clarence White of Salisbury, Md. The body will be taken to Wilkes-Barre tomorrow morning, at which place the funeral and interment will take place.

ASSAULT CASE HEARING

The hearing in the case of Charles Ross charged by his mother-in-law with assault, is being heard before Justice H. P. Johnson today. Ross is a Sayre man and a history of the case was printed in yesterday's Record. At the hearing today it is said that nearly the entire neighborhood is represented as witnesses. Mrs. Lorina Baker, the complainant, was on the stand nearly all the forenoon, and her story was full of fire and vituperation. She is capable of fighting a pretty fierce battle for herself.

**DIBBLE HAD A
HIGH OLD TIME**

Came to Sayre to Deliver Vegetables and Lands in the Bastille—Released on Suspended Sentence

Charles Dibble, a young married man who says that he has a wife and three children came here from Sheshequin yesterday to deliver a load of vegetables for the woman for whom he works. After attending to the delivery of the vegetables Dibble with nine big round dollars in his jeans drove from here to Waverly, and according to the story he tells himself, visited several thirst stores while in that place. In one of them he says he was hit in the eye by a fellow whose name he did not know. Dibble then says that he got mad and in order to sooth his wounded feelings proceeded to fill up on booze. Late in the afternoon, he wound up in Sayre and as he was making a nuisance of himself on the streets Chief Walsh consigned him to the bug house to sober up. The horse he had been driving was taken care of by the police and this morning Dibble was given his liberty, he pleading that it was his first offense and that it would be the last.

**SAXTON FERRIS WILL
BE RETURNED TO SAYRE**

Preliminary Steps for His Return to this Place Were Made Yesterday

The preliminary steps for the requisition of Saxton Ferris who at present is confined in the Tioga county jail at Owego, were taken yesterday. Ferris is charged with stealing from the Lehigh Valley railroad company a number of headlight reflectors to the value of \$29.75. He was arrested at Waverly about two weeks ago on a warrant issued in Sayre, and was later held by the New York state authorities to await requisition. District Attorney Mills yesterday completed the preliminary papers, an operation which involves an endless amount of detail and hard work. The papers will be sent to Governor Pennypacker today and it is expected he will take the matter up at once and call upon the Governor of New York state to surrender Ferris to Robert DeGroff the officer named as agent to go to Owego and return with the man wanted.

**CALL BY NUMBER
INSTEAD OF NAME**

Telephone Company Has Issued a New Edict Regarding the Manner in Which Central Shall be Called

Hereafter when you desire to communicate with a subscriber on the Valley Telephone company's lines it will be necessary to tell the operator at the central exchange the telephone number of the party you wish to talk with. A new edict has been promulgated by the powers that be and the operator at the switchboard will no longer listen to your request, "give me Josiah Smith's residence, please?" but you must give the number in plain English terms. Heretofore it has been the invariable custom to call the party you wanted by giving the name, but the telephone managers will no longer stand for this method as it is claimed that the numbers in the telephone book are expressly for this purpose and that by calling in this manner the work at the switchboard is greatly facilitated. From the standpoint of the telephone management the rule is a good one, but the patrons of the system have found it a very convenient method to tell the central operator the name of the person wanted, thus obviating the necessity of searching for a telephone book which has either been mislaid or perhaps may not contain the number of the party desired.
