## LEHIGH EMPLOYEE FOUND UNCONSCIOUS

Stricken With Apoplexy in His Room at the Wilbur House Yesterday Afternoon

Yesterday afternoon Z. T. Henniger, a Lehigh Valley employe, was found in his bed at the Wilbur House in an unconscious condition by the dining room girls who had gone to his room to ascertain whether he wanted dinner. In the morning Mr. Henniger had not been feeling well and did not go to work. At noon time an employe of the hotel went to his room with a bowl of soup which he ate with apparent relish, but later when the girls visited the room he was found to be in an unconscious condition. Dr. Theodore Wright was summoned and after an examination stated that Mr. Henniger was suffering from a slight stroke of apoplexy. He remained unconscious for several hours, but this morning his condition is much improved and there are excellent chances for his complete recovery. He is employed at the round house and is in charge of the electric turn table.

## DISCUSSING TOWN HALL QUESTION

Committee Held Meeting Yesterday and Considerable Progress Was Made

The town hall committee of the borough council held another meeting yesterday afternoon in the office of Councilman C. C. West to further discuss preliminary plans for a new building. Architect T. I. Lacey, of Binghamton, submitted plans which were in many respects similar to the ones used in the erection of the public building at Lestershire, N. Y. The plans, however, call for a much more expensive building than can be afforded in this town, and the architect was given an idea of what is wanted by the committee, and he will submit another set, which will probably arrive here the latter part of the week. The committee will quite likely hold another meeting on Saturday next, at which time it is hoped that matters will have progressed far enough to make a definite report to the council on Monday evening.

## CHESTER BENTON TAKEN TO FREEVILLE

The Lad Taken in Custody Here Yesterday Is Wanted for Larceny

Nathaniel Lynn Bedford, an attaché of the George Junior Republic, located at Freeville, N. Y., arrived in Sayre early this morning to take Chester Benton back to that institution. Benton is the 18-year-old lad who was captured here yesterday by W. R. George while the former was stealing a ride on a Lehigh Valley passenger. He is wanted at the republic for larceny, having been held in the sum of \$100 bail. He will be compelled to stand trial when he gets back to the institution, and the authorities will see that he does not escape a second time.

## FORD HELD TO COURT

S. McA. Ford, charged by the government authorities with conspiracy in connection with the sale of a work known as the Congressional Manual, has been held by United States Commissioner John W. Mix in the sum of \$1,000 for his appearance before the United States Court at Harrisburg on the first Monday of May. The government claims that the book was being sold under false pretenses. The hearing was held in the grand jury room at the court house in Towanda yesterday and a large number of witnesses were examined.

## CAME TO SAYE AND GOT "TIGHT"

Chemung County Farmer Was Loaded to the Limit Here Yesterday

Last night a couple of women reported to Chief Walsh that a man was lying in a helpless condition on the foot bridge and asked that he be taken care of. The chief went to the bridge and brought the man to the lockup. He was helplessly drunk and when arraigned this morning gave his name as Joe Smith, and said that he lived up in Chemung county, N. Y. He said that he must have been "tight" as he had no recollection of coming to Sayre and did not know where he was until told by the police this morning. He said that he left home yesterday morning to go to Waverly to get some teeth pulled, and in order to get up good nerve for the dreaded operation he took a drink of Waverly whiskey. Since taking the beverage he claims to have no recollection of what occurred until this morning. When he left home he says that he had \$50 in his inside pocket, but when searched by the police a lonesome looking ten dollar bill was all that was found. Smith contributed to the borough fund and departed for Chemung county, declaring that he would never get "tight" in Sayre again.

## AUBURN SUFFERS DISASTROUS FIRE

Flames Destroyed Two of the Finest Business Blocks in the City Last Night

The city of Auburn suffered a \$150,000 fire last night. Flames broke out in the Columbus and Temple Court blocks about 7 o'clock and in a short time were beyond the control of the local firemen. Syracuse sent aid and it was not until 2 o'clock this morning that the fire was gotten under control. The loss is estimated at \$150,000 and two of the finest blocks in the city are a mass of ruins. Chief Jewhurst of the fire department and three firemen were overcome by smoke. The conflagration is the most disastrous one that has occurred in Auburn in years.

## FUNERAL TODAY

The funeral of Benjamin Bentley, the 13 year-old son of Mr. and Mrs. Daniel Bentley of West Lockhart street, who died suddenly in Dr. Fish's office on Monday afternoon, was held today. Services were conducted by the Rev. E. M. Bessler at the parents' home at 12 o'clock and at 12:30 o'clock at the church. The remains were placed on board a special car attached to the Lehigh Valley milk train which leaves Sayre at 1:40 and taken to Towanda for interment. The obsequies were largely attended by school mates of the deceased.
