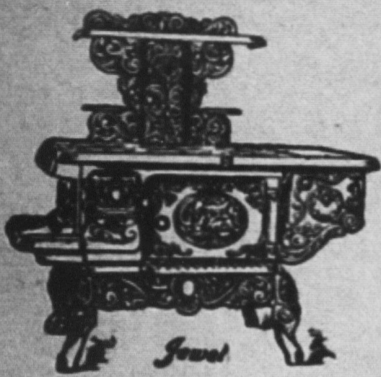

MARTIN'S HOME IN BAD CONDITION

So Say His Neighbors - Who Cause His Arrest on a Charge of Non-Support

Reed Martin, a resident of Thomas avenue, was held to court last night in the sum of \$100 bail for neglecting to provide for his wife in a proper manner. Martin was arrested on warrant sworn out by County Detective McGovern, and the circumstances connected with the case are of a most unusual nature. Martin's wife, who is about 22 years old, is a sufferer from St. Vitus' dance, and at times she is attacked in a most violent manner. When suffering from one of the attacks she becomes almost unmanageable, and if not restrained does herself bodily injury. Two weeks ago Drs. LaPlant and Haines were called to attend the woman, and according to the story told by them and other witnesses at the hearing which was held last night, the conditions at the Martin home are not what they should be. Martin is away the most part of the time and during his absence the house has been left in charge of a young woman, who is a cripple and is said to be physically unfit to give Mrs. Martin and the house such care as is necessary. The house is alleged to be in a very unsanitary condition and Mrs. Martin's personal toilet has become such that Dr. Haines asserts that there is no use prescribing medicine until something is done to better the surroundings and clean things up. The matter was reported to the secretary of the board of health, but as that body had no authority to act, several of the neighbors made a complaint to District Attorney Mills and that official decided that Martin was chargeable with neglect. Accordingly an investigation was made yesterday by County Detective McGovern, and enough evidence was secured to warrant legal action being taken. A half dozen witnesses, who at various times had visited the Martin home, were sworn, and all testified to practically the same story. According to their statements the condition of the woman is most deplorable. She tears her clothing from her body when suffering a violent attack, falls from the bed to the floor, and her body is covered with innumerable bruises which she has received while falling about the house. The neighbors have been to the house and relieved conditions as much as possible, but they insist that the woman must have better care.

Martin made a statement in his own behalf and said that he considered he had done all he could under the circumstances. He called his father-in-law as a witness, and while that gentleman did not feel like blaming Martin altogether, he admitted that his daughter's home was not being cared for as it should be.

Mrs. Martin has one child and is said to be a highly respectable young woman, who has been overtaken by misfortune that demands good care and attention on the part of her husband.

Martin's father-in-law qualified as his bondsman for appearance to court. The case will come up before Judge Fanning the first week in May.

BREWING COMPANY'S NEW STORAGE PLANT

Stegmaier's Will Erect at Wilkes-Barre One of the Finest in the Country

The building will be six stories high and have a frontage of 107 feet. It will be of stone, steel and hydraulic pressed brick, and when completed and furnished will represent an outlay of \$175,000. With the addition of the new storage plant the brewery will have a capacity of nearly 500,000 barrels of beer per year. The new storage house will be a beauty from every standpoint. It will embody all of the latest structural materials and its exterior architectural features will be presented to excellent advantage. The sanitary regulations will be absolutely perfect, guaranteeing a product which will be unequalled for its purity and cleanliness. The constant increase of business of the vast establishment has rendered the addition of the storage plant an absolute necessity.

LILLEY'S KEEN SENSE OF HUMOR

As a Humorist the Honorable Mial E. Is Certainly a Howling Success

An article in the North American says Congressman Mial E. Lilley declared at a gathering in Philadelphia a few evenings ago that "the next Republican convention will be representative and that its work will be endorsed by the Republicans of the state." He declared "the need of reforms, including removal of the embargo placed upon the electric railways, the abolition of the fee system in all offices, the regulation of freight and passenger rates, the abolition of the \$10 rebates upon mileage books, and no more free passes, and finally, an adjustment of taxation of corporate interests."

Congressman Lilley is known to possess a keen sense of humor, but if the statement credited to him was correctly quoted, he has shown that he is "the limit" when it comes to cracking a joke. But the reforms mentioned in the article are no joke. The fee system as it obtains in Pennsylvania is a very fine thing for office holders and a burden on the persons who are compelled to transact business with them. Congressman Lilley knows all about the fee system, as he was prothonotary of Bradford county for six years. Did anybody ever hear him advocate the abolition of the fee system while he was pulling in the fat fees of that office? The withdrawal of free railroad passes is a thorn in the flesh of politicians. It surely must be galling to a man who is giving his services to his country to be obliged to dig down in his jeans like any ordinary citizen and produce the coin for a railroad ticket, especially so when a man has been accustomed to traveling on a free pass. But what caps the climax of iniquity to a politician now is that he must put up the \$10 excess on a mileage book just like Bill Smith or Tom Jones, or some other common mortal. Of course Mial is "agin" such outrageous practices now. Has it ever been recorded that he held the same views during his first term in congress? We throw not.

The congressman's "reform" announcement has come too late. The time for a politician to reform is before the people get him into a corner. The day has gone by when he can raise "high jinks" with his constituents and then be reelected by promising to be good.

Congressman Lilley has had an opportunity to see a great deal of handwriting on the wall; in plain English, he is frightened at the political outlook in his own district. It reminds one of the old saw:

"When the devil was sick,
The devil a saint would be;
When the devil was well,
The devil a saint was he!"
