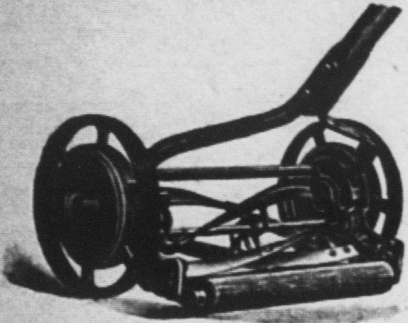

ITALIAN TRAIN RIDER KILLED

Jumped from Freight Car Near Wysox and is Fatally Injured

At 7:30 o'clock Saturday evening, Frank Ghesione, an Italian, died at the Packer hospital from the effects of terrible injuries received in jumping from a Lehigh Valley train between Standing Stone and Wysox. Ghesione had been employed by the company for some time on the stone ballast, but recently had received a letter from a friend in New York city telling him to come to that place and that he could secure a better job. Saturday he came to Sayre to get his pay, but learning here that he could not get it until pay day, he concluded to return to the place where the gang in which he had been working is located. The train which he boarded did not stop at that point, but Ghesione jumped off. He stumbled and fell beneath the wheels. His skull was crushed and a deep gash was cut in the top of the right shoulder. When picked up by the train crew he was still alive and was placed on board an engine and hurried to the hospital at this place.

The remains were removed to J. W. Grumme's undertaking rooms and will be held awaiting the arrival of friends.

This morning several Italian friends of the dead man took charge of the funeral arrangements. A brother of the deceased resides in New York city and a telegram was sent to him. If he does not come here to defray the expenses of the burial it is quite likely that a subscription will be taken up among the foreigners for this purpose.

FORMER SAYRE RESIDENT DEAD

George Canoll Died at the Home of His Son in Waverly Last Night

George Canoll, formerly of Sayre, died last evening at seven o'clock, at the home of his son, Charles N. Canoll, at 145 Chemung street, Waverly.

Mr. Canoll had been sick for some time from pneumonia, but had so far recovered as to be out on the street, but he was again attacked by the disease, and succumbed within a short time.

Deceased was 70 years old, and resided on North Elmer avenue in Sayre up until about a year ago when he retired from his work as a machinist in the Lehigh shops and went to live with his son in Waverly. He was a resident of Sayre for over 26 years, and had been an employee of the Lehigh for over 35 years.

He was well known in this place and served three terms as councilman from the second ward of this village.

He is survived by two sons, Edwin and Charles, with whom he resided.

The funeral will take place Wednesday afternoon at 2:30 o'clock at the house. The Rev. H. W. Cryden will conduct the service, and the remains will be buried at Tioga Point cemetery, Athens. E. S. Hanford has the funeral in charge.

SURPRISE SPRUNG IN JOHNSON TRIAL

At orneys for Defense Present Case to Jury Without Offering Any Evidence.

A surprise was sprung by Attorney Wilson for the defense in the Johnson murder case on Saturday when he announced to the court that no witnesses would be called in behalf of the prisoner Mr. McPherson, of the counsel for the defense, declared that the case of the commonwealth as presented to the jury was not sufficient to convict.

At the Saturday afternoon session of the court Johnson's attorneys asked the court to instruct the jury to return a verdict of not guilty, contending that the commonwealth had utterly failed to connect the prisoner with the crime Mr. McPherson claimed that the corpus delicti or the body of the crime had not been proven, and that if a crime had been committed that the defendant had in no way been connected with it. Mr. Maxwell for the commonwealth argued the case from an entirely different standpoint, and claimed that sufficient evidence had been presented to the jury for them to consider and upon which to return a verdict.

LADIES' AUXILIARIES IN SESSION HERE

Over One Hundred Delegates Are in Attendance—Banquet This Evening

Trainmen's hall presented an animated scene today when over one hundred delegates representing the various ladies' auxiliaries of the Order of Railway Conductors in this section gathered for the purpose of receiving instruction in the workings of the order and also to enjoy a couple of days in a social manner.

The first session of the school opened this morning at 10 o'clock and was presided over by Mrs. A. L. Moore, grand president of the order. She is assisted by Mrs. Welsh of Elmira, district deputy president. The morning session was attended by a large number of Lehigh conductors and their wives.

This evening at 7 o'clock a banquet will be given in the I. O. F. hall. Daly's orchestra will be in attendance and plates will be laid for over two hundred.

WAR VETERAN DEAD

William Hendrickson, an aged veteran of the Civil War, who has been a resident of Sayre for the past eighteen months, died Saturday afternoon at the home of his daughter, Mrs. George H. Deidrick, of No. 122 North Hopkins street. Death was due to the infirmities of old age.

The deceased was born January 3, 1833, at Albany, N. Y., and when the war broke out joined one of the New York state regiments. He was taken prisoner and was for a time confined in one of the rebel prisons. Besides Mrs. Deidrick he is also survived by a sister who resides in Brooklyn, N. Y. The funeral will be held from his daughter's home tomorrow afternoon at two o'clock, burial at Tioga Point cemetery.

FUNERAL TODAY

The funeral of James Merrill, whose death occurred on Friday evening, was held from his late home on Keystone avenue this afternoon at 3 o'clock, the Rev. W. H. Sawtelle of Ulster, and Rev. M. B. Wood, pastor of the Church of Christ in West Sayre, officiating. The pall bearers were D. W. Tripp, C. T. Hull, I. N. Evans, Elmer Gregory and H. F. Maynard. The remains were taken to Tioga Point cemetery for interment.

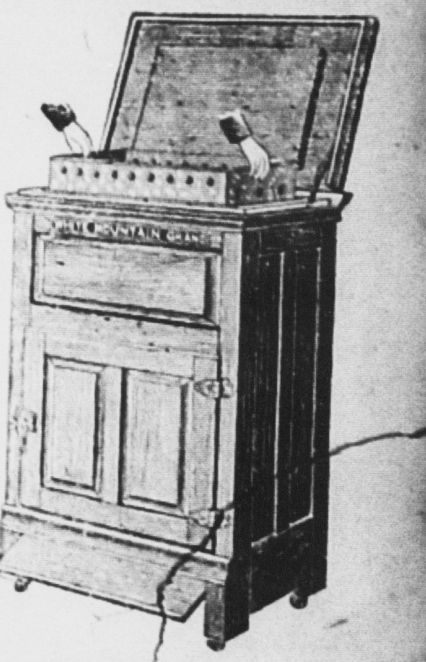
