ITHACA MAN IN TROUBLE AT SAYRE

Boarded Excursion Train Yesterday Without a Ticket and Kicks up a Disturbance

Yesterday morning when the Lehigh Valley excursion train left Ithaca for Binghamton a man who gave his name as W. R. Manning boarded one of the coaches, but when the conductor collected tickets Manning was not in possession of the necessary piece of paste board to entitle him to ride. Manning was fairly well loaded with whiskey and when asked for his ticket kicked up a row. The conductor told him that when the train reached Sayre he would have to get off, and during the remainder of the trip he was decidedly ugly. He butted into a party of negroes, and one of them wouldn't stand for his lip and struck him in the face, cutting gashes in both the upper and under lips. When Sayre was reached Manning was still in a quarrelsome mood and he was turned over to Officer Bob Degroff. The latter took Manning to the lockup and later in the day he pleaded guilty to drunkenness and disorderly conduct. He was released on suspended sentence and was at once taken to the hospital where the injuries he sustained to his face were attended to by the surgeons.

DOUBLE FATALITY AT SOUTH WAVERLY

One Man Killed by Falling Through Bridge and the Other Is Fatally Injured by the Cars

Waverly—Last Saturday night shortly before 10 o'clock James E. Morris, a well known farmer residing near Wilawanna was fatally injured by falling through the Elmira street bridge over the D. L. & W. railroad, to the tracks below, a distance of about 20 feet. His neck was dislocated and he received several other lesser injuries from which he died about 15 minutes after he was found. Mr. Morris had driven down to Milan and Greenlanding during the day and reached Waverly in the evening. He was on the street talking with his friends, and about 9:30 he got his horse and started to drive home. The animal is young and fractious, and Mr. Morris had been warned against driving it, but as he was hitched to a sulky he thought that he would have no trouble. Nothing more was seen of him until the 10 o'clock car crossed the bridge from South Waverly, and ran against a sulky that was fast in the tracks on the north end of the bridge. The crew of the car and passengers heard groans and clambering down the bank found Morris lying on his back with his head on a stone. He was unconscious but his moans gave evidence of life. He lived only about 15 minutes, and when Dr. Griswold reached the scene he pronounced the man dead.

Street car rails have recently been placed across the bridge. The rails are laid on stringers and there are very few cross ties joining the rails, leaving the space between the rails open. The horse went between the rails and fell over the bridge abutment. Morris, striking on his head, but the sulky remained hanging on the rails. The horse went over the edge of the abutment and the calk marks are visible all the way down the face of it. The horse was found a short distance up the track from where the accident occurred. It was able to walk but it is badly banged up.

No one has been found who saw the accident but it is thought that Morris reached the road at the north end of the bridge just about the time that the 9:42 D. L. & W. train passed that point. His horse was afraid of the cars and probably became frightened and in the mix-up went through the bridge.

The report that the dead man was intoxicated is declared to be untrue by his friends who were talking with him shortly before he started for home. Chief Brooks states that he had considerable conversation with him only a short time before and that he had not been drinking; that he was a man of very temperate habits.

Mr. Morris was 72 years old and had lived at Wilawanna nearly all his life. He has a host of friends who deeply regret the sad accident. Two sons survive him, one of whom resides on the home farm.

The funeral will take place tomorrow at 1 p. m. at his late home in Wilawanna.

A coroner's jury was empaneled, Justice Edmiston presiding. Some evidence was taken but they adjourned until Friday evening.

After a number of people had gathered at the scene of the accident to Mr. Morris, groans were heard up the track. On investigating a man was found lying on the track with both legs off. He was taken to the town hall at South Waverly and Dr. Tucker called. The ambulance came up from the Robert Packer hospital and he was taken to that institution, but died about five minutes after he arrived there.

His name was Al. Bradley and he lived in South Waverly. He stated Saturday night that he was going to take a D. L. & W. freight to Elmira, and it is supposed that he was trying to catch a train and fell under. The opinion was first expressed that he and Morris

were together, but as he was found at a point nearly 300 feet east of the bridge that theory seems very improbable.

The funeral will be held at his home Tuesday forenoon at 9 o'clock, the Rev. A. B. Cook officiating. The body will be taken to VanEtten, N. Y., over the Lehigh Valley. Burial in Mount Hope cemetery.

LIGHTNING IGNITES GAS

Waverly—Lightning struck the house of John Secord on Lincoln street last Saturday, knocking some brick off the chimney and breaking a hole in the roof. The bolt went into the basement, melted the gas pipe from the meter and ignited the gas. The fire alarm brought a ready response from the firemen, who were wet to the skin by the terrific downpour of rain. After turning off the gas, the fire was extinguished with the chemicals. Little damage was done to the house.

BLEW HOUSE DOWN

Waverly—A terrific wind storm visited Waverly yesterday at about 1 p. m., and for a few minutes it seemed to the inhabitants as though the appearance of the place would be considerably altered. Several trees were blown over, and many large limbs were broken off others. E. E. Rhodes is building a new house on Eliot street, the bare frame was all that had been erected, but the wind caught it and blew it down, breaking off nearly all the studding.

Political Announcement

To the Republican Voters of Bradford County:

In formally announcing my candidacy for re-election to the office of Representative in the legislature from Bradford county, I recognize the right of my constituents to know my attitude, both past and future, on those questions which are of such vital importance to the country at large.

I therefore desire to state, that if re-elected, I shall favor the following legislation, and will introduce and work for the enactment of these subjects, viz:

The amendment to the Constitution whereby the basis of the representation in the law-making body shall be citizenship and not an indiscriminate population of foreigners centered in the large cities to the prejudice and exclusion of the agricultural districts.

The revision of the tax laws so that all kinds of property and franchise shall pay the same millage on the dollar of valuation.

The limiting of all franchises to a reasonable length of time.

The granting of trolley roads of all privileges enjoyed by steam railroads, including the right of eminent domain and the right to carry freight.

The retention of all license fees and personal property tax by the county.

The increase of the state aid in the township road law from 15% to 50%.

The granting to the people at large more power to decide some of the more important questions, such as the granting of franchises, municipal ownership of public service corporations and matters of a local character.

The repeal of the iniquitous sheriff's fee bill.

The final disposition of petty misdemeanors before a justice of the peace and a jury of six, whereby a large portion of the expense of maintaining the criminal courts will be eliminated.

The enactment of legislation providing for equality of rates charged by transportation companies, both freight and passenger, and a maximum passenger rate of two cents per mile.

Increased appropriation to public schools, especially township high schools, even to the extent of the state bearing the entire expense of maintaining the public school system.
