British Captains Released.

WASHINGTON, July 11.—Governor Magoon at Panama confirms the report that a Colombian warship had seized at a point off the Colombian coast.

The governor says, however, that the commander of the Carthagenas, the Colombian ship, upon discovering that the men were British subjects immediately released them.

Professor Mitukoff for Premier.

ST. PETERSBURG, July 11.—Professor Paul M. Mitukoff appears from interviews last night with several leading members of parliament to be the man of whom the Constitutional Democrats are waiting for premier in the event of a successful issue of the negotiations for the formation of the constitutional Democratic ministry.

ST. PETERSBURG, July 11.—A dispatch from Tambov, says that a mutiny, followed by serious fighting, has broken out among the troops forming the garrison there, due to an attempt of the military authorities to arrest and disarm the Seventh Reserve cavalry, who "struck," presenting a series of political and service demands.

They cut their way through other troops to the barracks, where they barricaded themselves and beat off repeated attacks of the loyal troops. Shots could still be heard at midnight. The detachment of the Seventh at the railway station cut the telegraph and telephone wires and is holding out there.

An officer of the railroad corps and the commanding officer and a sergeant of the Seventh cavalry are reported to have been killed, while many were wounded.

Admiral Rojestvensky, on trial on the charge of surrendering to the enemy after the battle of the Sea of Japan, has been acquitted after the court had deliberated for nearly ten hours.

Four officers of the torpedo boat destroyer Bedovi, who were placed on trial with the admiral, were found guilty of having premeditatedly surrendered the Bedovi, and all four were condemned to death by shooting.

But on account of extenuating circumstances the emperor will be requested to commute the sentences of the four officers to dismissal from the service and to be deprived of certain rights which they would otherwise enjoy.

A naval court of inquiry June 7 presented an indictment against Admiral Rojestvensky, who commanded the Russian fleet at the battle of the Sea of Japan, and the officers of the torpedo boat destroyer Bedovi for surrendering to the enemy. The indictment was a crushing arraignment of the demoralization and cowardice of the officers, contrasting their conduct with that of the officers of the torpedo boat Grozny, which in practically the same position as the Bedovi engaged and sank a Japanese torpedo boat.

The testimony brought out details of the cold blooded way in which Captain Baranoff of the Bedovi abandoned the crews of the battleships Oshaba, Kikaz Suvaroff and Alexander III. to death by drowning. The president of the court virtually called Baranoff a coward in open sitting.

Rojestvensky submitted his case, in lieu of pleading by counsel, in the following words: "Sir—Russia's fleet has been humiliated. The people have confidence in you. I await my punishment."
