## DANTON DEMANDS \$5,000 DAMAGES

Charges Dr. L. B. Denison with Having Alienated the Affections of Mrs. Danton

Charged with alienating the affections of another man's wife, Dr. L. B. Denison, Sayre's well known physician, was yesterday afternoon placed under arrest by Sheriff Griffin, and later in the evening gave bail in the sum of \$5,000 for appearance before the court of common pleas of Bradford county. The complainant in the case is Steven Danton, a Lehigh Valley engineer, who is also well known and who has resided in Sayre for a number of years. Denison was arrested on a capias, or as it is sometimes termed a civil warrant. The complaint in the case was drawn yesterday by Paul E. Maynard of the firm of Maynard, Maynard & Schrier, and covers several type written pages. As soon as the complaint had been sworn to by Danton, Attorney Maynard went to Towanda and a capias was issued out of the prothonotary's office. The document was immediately placed in the hands of Sheriff Griffin who came to Sayre on No. 7. A few minutes after his arrival he took Denison in custody. In the complaint bail in the sum of \$5,000 was demanded, but Denison immediately retained the Hon. E. M. Dunham and Hon. L. T. Hoyt, and they called Judge Fanning up on the telephone with the result that the bail was reduced to \$5,000. Late in the evening bondsmen appeared and qualified and Denison was released.

The complaint sworn to by Danton contains many specific allegations and covers the relations of the parties to the affair since March 1st, 1904. It is alleged by Danton that he was married to his wife, Belle Danton, in June, 1898, and that in 1901 they came to Sayre to reside. About March 1st, 1904, they went to the home of the defendant on Lincoln street to reside. Shortly after they began housekeeping at the home of the defendant, Danton alleges that the defendant began a course of conduct with Mrs. Danton which tended to cause her to treat her husband with great disrespect, and to transfer her affections from her husband to Denison. It is further alleged that Denison encouraged her in this course, and that he so influenced her that she finally treated her husband with hatred, and transferred her love and affections to the defendant.

As a further cause for complaint Danton alleges that on or about August 22, 1906, he made an effort to get his wife away from the home of the defendant, and secured for himself and wife board and lodging at one of Sayre's principal hotels. He tried to induce his wife to go to the hotel with him, but that owing to the control exercised over her by the defendant she absolutely refused, and at the same time used violent, blasphemous and indecent language toward her husband. Danton then went to another place to reside, but he alleges that his wife has continued to reside with Denison, and that the two have been living together in criminal relations.

Danton further charges that she has completely transferred her affections from her husband to Denison, by reason of the influence exerted over her by the defendant. Danton also charges that by reason of the relations existing between his wife and Denison, he (Danton) has been subjected to undesirable notoriety and held up to public scorn.

Danton asks for the sum of \$5,000 for the damages he has sustained to his feelings and for being deprived of the company and fellowship of his wife.

While the arrest of Denison caused considerable talk last night, it did not come in the nature of a surprise, as it was well known by many that litigation of a serious nature would eventually grow out of attachment proceedings which were begun by Denison last week. The outcome of the case will be watched with interest on account of the prominence of the parties.

## NO UNION AT WEATHERLY

The first machinist to make application for work at the Lehigh shops at Weatherly in five years was engaged on Thursday. About six years ago an attempt was made to organize a machinists' union among the employes of the shop. A charter was secured for which the sum of \$25 was paid, but the bosses got wind of the affair and reported it to headquarters. Notice was subsequently served on the men that the formation of a union would result in the removal of the shops from Weatherly. This had the desired effect and when the organizer appeared on the scene the men avoided meeting him for fear of being seen talking to him and losing their positions. The charter was later sold to the Tamaqua machinists for \$1. The story of the episode was spread and no full fledged machinist made application for work there until Thursday.
