W. R. STEVENSON DIED SUDDENLY

Expired This Afternoon at His Home on North Elmer Avenue After Only a Few Hours Illness.

After an illness of only a few hours William R. Stevenson, of 113 North Elmer avenue, expired this afternoon at 12:45 o'clock. The death of Mr. Stevenson will come as a great shock to his many friends as only his relatives and a few of the immediate acquaintances of the family were aware of his illness.

Yesterday Mr. Stevenson and his wife went to Tioga Point cemetery to visit the grave of John Straus, a brother of Mrs. Stevenson, who was buried on Saturday last. When they returned home Mr. Stevenson complained of not feeling well and he visited the office of Dr. H. S. Fish. He passed a fairly comfortable night, but about noon time today he grew worse rapidly and Dr. Fish was called to the house. When the physician arrived Mr. Stevenson was beyond medical aid and only lived a few minutes. Death is attributed to acute indigestion. Mrs. Stevenson is nearly crazed with grief and collapsed shortly after the announcement that her husband was dead. This is the third death to occur in the family within the past six months.

The deceased was about 32 years old and was one of the most popular young men in town, and numbered his friends by the score. He was employed as a machinist in the Lehigh Valley shops, and was known as an honest and upright citizen. He was prominent in church circles and was a vestryman in the Church of the Redeemer. He was also a member of the Fraternal Order of Eagles. His death will be regretted by all who knew him.

He had resided in Sayre nearly all life and was a member of what is regarded as one of the oldest families in the valley.

Besides his wife he is survived by his father and mother, Mr. and Mrs. George H. Stevenson of Jersey Shore, this state, and several brothers, nearly all of whom are residents of Sayre. The arrangements for the funeral which will be in charge of Grumme's undertaking establishment, have not as yet been made.

G. CLAUD COON KILLED NEAR CANTON.

Placed Beneath a Log and Sustained Injuries From Which He Died.

A distressing accident occurred on South Mountain, near Canton on Tuesday afternoon when G. Claude Coon, a son of the Hon. Giles M. Coon, a former member of the legislature from this county, was pinned beneath a falling log and sustained injuries from which he died a few hours later. The young man was about 30 years old and was engaged in drawing logs. One of the logs slipped from the load and fell upon him, fracturing a number of ribs. The ragged end of one of the broken ribs punctured the lungs. His face was also badly lacerated. He was taken to his home and medical aid was summoned. It was of no avail, however, and he died a few hours later. He was the oldest son of Giles M. Coon and had scores of friends. He leaves a wife and two children.

MESSANGER JURY AGAIN IN COURT

Two of Them Declared That They Were Ill, But the Judge Refuses to Discharge Them on This Ground.

About ten o'clock this morning the jury in the Messenger murder case came into court at Towanda and reported that they were still unable to agree. Two of the jurors also reported to the judge that they were ill and they asked to be relieved from further consideration of the case. The judge refused to permit the jury to be discharged and sent them back to find a verdict one way or another.

Had the jury been discharged on account of the sickness of two of the members it would have resulted in another venire being issued and Sharrone would thus be compelled to undergo another trial, but should the jury report a disagreement, under the ruling of the Supreme court that when a jury is once sworn in a capital case the defendant is then placed in jeopardy. If the jury disagrees and the defendant was placed on trial again he would then have been placed in jeopardy twice for the same offense, and this would clearly be a violation of his constitutional rights. The jury has been out since Saturday afternoon last and it begins to look as if they would not be able to reach an agreement.

Since the above was placed in type the jury came into court and were discharged on account of the illness of the two jurors mentioned. Sharrone, who was present in court, was remanded to his cell in the jail. The action of the judge in discharging the jury before they returned a verdict will result in another trial.

INJUNCTION CASE HEARD TUESDAY AT OWEGO.

Waverly—Judge Lyon of Binghamton, sat at Owego Tuesday and heard the evidence, and listened to the arguments of the attorneys in the injunction case between the village of Waverly, and the various companies concerned. Senator Hinman of Binghamton and F. A. Bell of Waverly, appeared for the village. Mr. Thomas Keenan was present to look after the interests of the W. S. & A. company. The Elmira, Corning and Waverly company was represented by Fred Collins, while F. E. Hawkes appeared for the Powers Mansfield Co.

Considerable evidence was introduced. The judge instructed the attorneys for several parties to the suit to submit briefs after which he will render a decision.
