FIREMEN DISCUSS THEIR GRIEVANCES

Lehigh Valley Men Tell General Manager Cutter That They Should Not Be Forced to Qualify as Engineers.

The reported layoff of the Lehigh Valley firemen, owing to their having failed to qualify as engineers, as required by the rules of the company, seems to be on a fair way to amicable adjustment. A delegation of firemen from the company this week visited Superintendent Cutter and discussed the question with him. Their reception is said to have been of the most cordial nature, and the firemen were assured that they would be given every possible consideration. As a result of the interview it was agreed that the time limit should be extended, during which the firemen would have time to qualify. This new rule if established will tend toward the desired qualifications asked by the men. Many of the firemen of long service regard themselves as improperly equipped for the duties of engineer, and not having this confidence they would rather continue in their present positions. It is stated that this new rule, while much in disfavor among the firemen, is being forced to an issue by the Brotherhood of Locomotive Engineers and that while the company is adverse to other than the most considerate treatment of its veteran it has no other alternative than to consider the demands of the engineers.
