# MAY RUN AGAINST STUMBLING BLOCK

Councilman Hassler Says Restraining Order Will Be Secured to Prevent Council Taking Further Action in the Sewer Matter.

When the Sayre borough council meets on Friday evening to complete the letting of the sewer job the members of that body are likely to run up against a stumbling block in the shape of an injunction restraining further action until the legality of the throwing out of the Wilkes-Barre Construction Company is passed upon by Judge Fanning.

Councilman Hassler stated to a Record representative today that the injunction will probably be applied for tomorrow and that document will be served before the council has opportunity to sign the contract with J. J. Higgins on Friday night.

It will be alleged, says Councilman Hassler, that the rejection of the bid of the Wilkes-Barre Construction Company was illegal, and that it should have been tabulated along with the other bids. Instead, however, Councilman Hassler claims that at the meeting of the council held for the purpose of opening the sewer bids the bid of the Wilkes-Barre Construction Company when reached by the borough clerk was laid one side by that official with the remark that it could not be tabulated because the bid had been made upon the original plans and specifications instead of the amended ones. Councilman Hassler says that the council apparently had no voice in the matter whatever and that the bid was thrown out without consideration.

Councilman Hassler says that the bid was made in good faith, by a reputable firm that it was accompanied by a proper bond, and that the council should have been given opportunity to pass upon its validity.

It will also be claimed by the petitioners according to Mr. Hassler, that much favoritism was shown in awarding the contract and that the entire proceedings are invalid and inequitable.

# MRS. SKINNER WILL ANSWER AT COURT.

Waived Examination Yesterday Afternoon and Bail Was Fixed at \$200.

Carrie Skinner, charged with adultery, was arraigned before Justice Carey yesterday afternoon and through her counsel the Hon. L. T. Hoyt, waived examination and was held to the next court of quarter sessions in the sum of \$200 bail. The prosecution was represented by District Attorney Mill. A large crowd which had gathered at the justice office, hoping to hear the details of the story of Mrs. Skinner's alleged misdoings were sorely disappointed when it was announced that a hearing would be waived and fled out of the court room wearing crestfallen countenances.

# TERRIBLE ACCIDENT.

Lewis Wells of Wells Township Probably Fatally Injured.

The Wells correspondent of the Review gives the following particulars concerning a terrible accident which happened in Wells township last Saturday:

"Lewis Wells of Daggett, met with a serious accident late Saturday forenoon. He had just sharpened and old fashioned long and wide bladed hay knife and accidentally fell upon it and lacerated himself in a frightful manner. Dr. M. E. Seafuse and his brother, Dr. S. M. Seafuse of Elmira, dressed the wound. Mr. Wells is in a critical condition.

# Brakeman Injured.

John Monroe, employed as a brakeman on the Lehigh Valley, had one of his hands severely squeezed yesterday morning while about his work. He was working on a branch of the Lehigh Valley cutoff that runs to one of the collieries near Avoca where his train was taking some loaded cars. He did the coupling and just as two of the cars were coming together his left hand slipped and went between the bumpers. The hand and arm were severely squeezed. He was brought to Wilkes-Barre and is being treated at the hospital. Monroe lives at 751 North Main street.

# Lewis E. W. Searles.

Lewis E. W. Searles, the eighteen-year-old son of Mr. and Mrs. Irvin W. Searles of Towanda, died at the Packer hospital this morning about three o'clock, after a few days' illness of appendicitis. The deceased was operated upon for the malady on Friday last. He was an employe of the novelty works at Towanda and is survived by his father and mother. The remains were taken to R. S. Loomis' undertaking establishment and will be sent to the parents' home at Towanda this afternoon.

# MADISON DIED IN BUFFALO YESTERDAY

Injuries Sustained By Sayre Man at Wende, N. Y., Prove Fatal.

Hardy Madison, the Lehigh Valley flagman, whose legs were cut off near Buffalo yesterday, died in the Emergency hospital in that city yesterday afternoon. The remains were brought to Sayre this morning on Lehigh Valley train No. 6 and taken to the undertaking rooms of Undertaker J. W. Grumme, where they were prepared for burial. Today the body was removed to his home at No. 111 Pleasant street, West Sayre.

Later particulars concerning the accident by which Madison met death are to the effect that he had attempted to climb the ladder of a moving car with a lantern in his hand. He grabbed the iron rung but missed his hold and fell under the cars, being dragged for some distance. Both legs were severed. He was hurried to the emergency hospital, but died within a few hours.

Madison was 38 years old and had worked for the Lehigh for many years. He was well liked by his fellow workmen, by whom he was well known. He is survived by his wife and five children, the majority of whom are of tender years.

# MRS. FLYNN IS IN DURANCE VILE.

Woman With a Record is Now Safely Caged in a Cell at Hotel Griffin.

Mrs. Hattie Flynn, wife of "Let-er-Go-Flynn," both of whom have police records that would fill volumes, is once more behind prison bars. Mrs. Flynn was recently indicted by a Bradford county jury. Shepard Bristol was bondsman for the woman, but when Mrs. Flynn was wanted in court she was conspicuous by her absence. Recently, however, her bondsman learned that she was in the vicinity of Sayre. Armed with a ball piece Bristol made a trip to this burg and when he returned to Towanda Mrs. Flynn accompanied him. He turned her over to Sheriff Griffin and now she is an unwilling guest at the former's hotel.

Mrs. Flynn is reported to have married a man up near Smithboro recently. It was said that the man was worth \$10,000, but just why he should allow the wife of his bosom to be carted off to jail is not apparent.

# NINETY PER CENT ARE PURE FAKES

Sayre Man Advised By Western Friend to Steer Clear of Mining Company Schemes.

Recently a Sayre merchant invested his cash in several thousand shares of mining stock. To be exact he purchased 4,000 shares for which he paid the magnificent sum of one cent per share amounting in all to forty dollars. The stock is of the dividend paying variety and the other day the Sayre man received a dividend amounting to about four dollars. The company in which he invested his forty dollars is alleged to be located at Denver, Col., and as the Sayre man has a friend who is at the head of a big realty and trust concern located in that city he decided to write to him, and asked for information concerning the mining company. Yesterday he received a reply as follows:

"Yours of the 6th last regarding the mining company received. I can only say that this company's name does not appear on the city directory and I know nothing about it. If you have already purchased property in this company and desire I will make further inquiry and get full particulars about it. If you have not done so, then I advise you as a friend not to buy any stock. I base this advice on experience in mines personally.

"I have 75,000 shares in Goldfield, Nevada Mining Company called the Goldfield Reliance Company, that is at the present time held at 16 cents per share. I would gladly sell all of this at 3 cents a share. I am using this as an illustration to show you the uncertainty of value of mining stock. You are too far from the field of action to buy mining stock. It requires too much attention and time, and the certainty of your money being used to develop the property is likely ten per cent. Ninety per cent of the mining companies are fakes and the chances of the company being legitimate are therefore only ten per cent. Actually striking it rich is not over 20 per cent which reduces to possibly 2 per cent the mining companies that will bring you returns for your investment."

The above quoted letter is from a man who is on the ground and who is wise to the various mining schemes and the advice he gives his friend in the east should be heeded by those who contemplate getting rich on a few dollars' investment. The stock which the Sayre man now holds at one cent per share was sold to him by a broker who at one time did business in Sayre.


