MAY APPEAL TO BOARD OF PARDONS

Supreme Court Files Refusal for Re-Argument in Johnson Case.

The silence of the supreme court, the tribunal which has the power to stay the executioner's visit to Charles Johnson, the condemned murderer, has at last been broken. The filing on Thursday of their refusal to grant a re-argument of the case, as far as the courts are concerned, blows out all hopes of the condemned. The pardon board may be appealed to intercede in behalf of the man convicted of complicity in the murder of Maggie Benjamin Johnson and her little niece at Macedonia. On Monday William P. Wilson, attorney for the prisoner received back from the supreme court his motion for a re-argument of the case. No letter or word of any kind accompanied the document and the lawyer was left in doubt. Thursday Mr. Wilson received a letter from the supreme bench stating that his motion for re-argument had been refused. It is not customary for the justices to file an opinion in cases of refusal, and none were expected in this case.

The one little word "refused" is insignificant in itself, but what a world of meaning it carries, especially for Johnson. It forever ends his chances in the courts of justice which have found him guilty of a fiendish, horrible crime, and only the pardon board can save him from meeting the fate which befell his brother, Bigler Johnson.

Johnson's attorneys may lay the case before the board of pardons and ask for mercy for their client. In order to do this the evidence in the entire case, together with all the records, affidavits, letters from responsible parties living in the community where the crime was committed, together with specific reasons for asking for a pardon must be filed with the board. The fact that a pardon is being asked for must be advertised in two county newspapers, the courts and police department must also be notified, and there is no end of red tape in such a proceeding.

The power of the governor in capital crimes is very limited. Article IV, Section 9, of the State Constitution gives the governor exclusive power to remit fines and forfeitures and to grant reprieves, "but no pardon shall be granted or sentence commuted, except upon the recommendation in writing of the lieutenant governor, secretary of the commonwealth, attorney general, and secretary of internal affairs, or any three of them, after full hearing, upon due public notice and in open session."

TROUBLED CONSCIENCE.

Causes Man to Pay Debt of Long Standing.

Tales of "conscience" contributions are occasionally heard, men overcome by their conscience paying up old and forgotten, and oftentimes unknown debts. Dr. Champlin of Bloomsburg, was the other day surprised by receiving a letter accompanying several five dollar bills from a man in New York state. The letter explained that the money was in payment of a debt for medical attendance given by Dr. Champlin sixteen years ago when the physician and writer both lived in Towanda. So many years had elapsed, and so many non-collectable accounts does many a doctor have during his career, especially on first starting practice, that this particular debt was entirely forgotten. The sender of the money explained that at one time he had during recent times become converted to religion, and that he had also amassed considerable fortune, and was now amply able to pay off his old debts, that his conscience compelled him to do this. The letter is profuse with thanks and good wishes to the doctor, to whom the voluntary, though delayed settlement is satisfactory. The doctor intimates that there are others to be heard from.

MARONEY WILL BE BROUGHT TO SAYRE.

Governor Hughes Has Granted Requisition and Prisoner Will Be Returned Here Tomorrow.

This morning District Attorney Mills received word from the secretary of Governor Hughes of New York state that the requisition papers in the case of John Maroney, charged with having robbed the cash register at the Sayre house, had been forwarded to the Sheriff of Tioga County, N. Y., at Owego. Chief of Police James Walsh is named in the papers as the agent to go to Owego and secure custody of Maroney. He will leave on this mission tomorrow. Maroney will be brought here and taken before Justice Carey on the charge of robbery.

Diphtheria Houses Fumigated.

This morning Health Officer Brougham fumigated the house of Gules Robinson on South street, Milltown, and yesterday a similar service was performed by the health officer at the home William McGuire at No. 226 Keystone avenue. On Wednesday Mr. Brougham fumigated at the home of John Slater at No. 144 Bradford street South Waverly.

All of the houses in which there have been cases of diphtheria have now been fumigated by the health officer, and once more the borough is entirely free from the dread disease. Despite the fact that there have been a number of cases reported to the board of health during the past year, the mortality list is decidedly low.

Dispensary for Every County.

To empower the Department of Health, with the co-operation of the Governor to select one or two tracts of 500 acres in the State's forest land, and erect thereon buildings for the treatment of tuberculosis, is the object of a bill introduced in the legislature Tuesday. To provide for this the bill carries an appropriation of \$600,000 for the work for two years beginning with June 1st next. Health Commissioner Dixon has evolved a plan for the establishment of dispensaries in every county in the state where poor consumptives who may be unable to visit the proposed colonies may receive free treatment.

Will Install Officers.

Sayre Encampment No. 52, I. O. O. F., will meet this evening to install officers and the installation will be followed by a banquet. The officers will be installed by District Deputy Grand Patriarch Browning. It is also expected that the grand patriarch will be present.

Phillip Sheer.

Phillip Sheer, died about two o'clock this morning at his home at 131 Hoover street. He was 70 years of age and his death was due primarily to old age. He is survived by his wife and five daughters. The funeral will take place on Sunday next at 2:30 o'clock from his late home.

LOCKJAW FOLLOWS SERIOUS INJURY

Man Injured at Greenwood Tannery Is Brought Here for Treatment.

With his jaws firmly set as the result of blood poisoning Fred Camp an employe of the Union Tanning Company of Greenwood, was brought to this place on Lehigh train 127 last night and removed to the Packer hospital for treatment. Camp was injured one week ago yesterday. He was engaged in running a machine when his right leg got caught in the gear. Before assistance could reach him the leg was crushed from the ankle to the knee in a frightful manner. It was at first thought that the member could be saved, but on Wednesday signs of tetanus developed, and it was deemed advisable to bring him to the hospital at this place. When he arrived here the disease was developing rapidly. The anti-serum treatment will be administered in the hopes that his life may be saved.
