A WATCH CASE COMPANY ROBBERED.

Thousands of Dollars Worth of Gold Abstracted.

NEWARK, N. J., Nov. 3.—An extensive swindle and robbery carried on for over six months, during which time thousands of dollars worth of gold have been stolen from the American Watch Case Company of this city, was brought to light to-night by the arrest of Adolph Neuman, of 302 Dean street, Brooklyn.

Neuman was employed by the company to do its mixing and alloying. About six months ago, Otto H. Oppenheimer, of New York, manager of the company, noticed that the watch cases turned out by the company were not up to the standard they should be considering the quality of gold supposed to be used in them. After satisfying himself something was wrong, Oppenheimer applied to the Pinkerton Detective Agency to ferret out the mystery. Detectives were put to work on the case, but according to Oppenheimer's statement, all they did was to land in voluminous reports of their work.

Ten days ago he notified the Newark police and Detective Cosgrove was detailed on the case. Cosgrove concealed himself in the factory several days and evenings in a position where, undetected, he could watch Neuman at work through a hole in a partition. While thus engaged he noticed that Neuman, in mixing the metal for the cases, used in addition to the sheet gold another metal similar in appearance to copper. He also followed Neuman every night after leaving the shop, and found he went to a certain place in Newark, the location of which the police will not at present disclose, where he sold the stolen gold in large quantities at 45 cents a karat, the market price being \$1.35.

After securing evidence enough against him, Cosgrove to-night arrested Neuman after leaving the shop and when searched at police headquarters over \$50 worth of gold was found in his pockets. A visit was also made to the place where he had been selling the gold and nearly \$1,000 worth was found. Neuman, when confronted with the evidence, made a full confession and told the police where they could find hundreds of dollars' worth of the gold under a fireplace in his house. The police started for Brooklyn to recover it. The Watch Case Company is satisfied that his numerous stealings will amount to thousands of dollars.

Old-Fashioned Winters.
