Kansas Has Two Capitols.

TOPEKA, Feb. 23 .- The Dunsmore House "removed" the State capital to Kanapolis in exactly two minutes. The resolutions were offered by Mr. Mair, the "contestant member" from Kiowa, and in a 120 seconds it had received the sanction of the House, although some members who were opposed to it afterward protested, saying the resolution was railroaded through with indecent haste.

The resolution recites that the capital is now located near the eastern border; that western counties have been disfranchised by Republican rule for the purpose of holding the capital at Topeka ; that the conduct of the citizens of To-

peka recently has been in defiance of the wishes of the people of the State, and that the Kanapolis people have offered to duplicate the present State House without expense to the State; and declares that as soon as practicable, lawful steps shall be taken to remove the capital to that city.

The State Senate last night adopted a resolution declaring that the Supreme Court had no jurisdiction in the House muddle, and therefore no right to decide as to the legality of the House of Representatives. This is regarded as due notice to the Supreme Court not to render a decision in the case now pending, which will determine the legality of the Republican House.

The general belief that the Re publicans will be sustained by the Supreme Court caused these resolutions to be adopted. It is believed that it means war and an utter disregard of the courts by the Popu lists.

LATTER :--- The affair has been settled by the Supreme Court and his efforts to secure "something the Capitol will remain at Topeka.


