[Lawrence Bros. received the following letter from Wagner & Keit-meyer, architects, on Tuesday.] WILLIAMSPORT, Pa., April 23, 1894. LAWRENCE BROS., LaPorte, Pa. GENTLEMEN—You must see that all stone that go into and are used in the construction of the foundation and other walls for the Sullivan Co. Court House (under construction with you and now being built at LaPorte, Pa.) are properly bedded, fitted and put into place in the walls on their broadest beds and not set on edge; you will also see that the walls are well and securely bonded with through stones, (stones reaching through the walls) you will also see that all stone is firmly set in place on the walls. You will see that a through stone or binder is placed not to exceed five feet between centers on every course. You will see that plenty of cement is used in the grouting of the first courses to prevent any water from running through the walls. Give the walls your special care and attention. Do not allow outsiders to trespass upon the premises and interfere with the workmen. Yours truly, A. S. WAGNER.






Vicious Horses Shod in Martin's Horse Shoeing Rack.
