 James C. Brown, of Bloomsburg, is a prominent candidate for Congressional honors in the 17th district, comprising the counties of Sullivan, Columbia Montour and Northumberland. He was born in Millville, Columbia county, in 1848 of Scotch ancestors. He was reared a farmer boy, attending the common schools and seminary of his native place. At the age of 16 he became a student in Dickinson Seminary, Williamsport, from which he graduated in the classical course in 1868 with the highest honors of his class. The same year he was employed as a teacher in the Bloomsburg Literary Institute which subsequently merged into the State Normal School and where he remained until 1872, serving the last year as principal. He then engaged in civil engineering, was on the original survey of the N. & W. Branch R. R., of which he was director for eight years, is now city engineer also engineer in charge of the construction of the Bloomsburg river bridge, one of the finest and most substantial structures on the Susquehanna river. In 1875 he purchased the Bloomsburg Republican and has successfully conducted that paper. Has been school director some fifteen years and is now, always leading in the educational interest of the town of his choice. Is prominently identified with nearly all the varied improvements and enterprises of Bloomsburg. In 1884 was a delegate to the National Republican Convention at Chicago. His paper voices the true American sentiment that the times demand. A special friend of the laborer, the mechanic, the industries of our state and country and speaks in no uncertain voice or sentiment concerning the boys in blue, always defending their rights. Mr. Brown is eminently qualified to represent the 17th district in the House. May the conferees place him in the field.

Mr. Corbett and Mr. Jackson.
 The manner in which Mr. Corbett and Mr. Peter Jackson, past masters in the art of self defense, are trying to break away from their friends and get at each other is most exciting. So far they have not been able to meet, and their struggles are pitiable. There are so many barriers between them. Mr. Corbett suggests Florida. Since the dispute with Mr. Mitchell there has been no reason why a glove encounter could not be brought off in Jacksonville. There is a club there willing and anxious to give a purse and treat the visiting pugilists with respect. But Mr. Jackson won't go there. There is ample opportunity in New Orleans. But to New Orleans Mr. Jackson objects. He is a colored man, and he claims that there is a feeling against colored men in the South anyway. So he is looking for a Northern or Western State.
 Both Mr. Corbett and Mr. Jackson are willing to fight in Pennsylvania or New York, for instance. It is easy for them to come to terms upon such States, for there is not the slightest chance that a fight could be brought off. Both contestants would be lodged in jail. And so it is with every other State that prevents, and when Mr. Jackson and Mr. Corbett put on their gloves, punch the bags, get into training and talk loudly about their willingness to fight in Colorado or Washington State or in Dakota they are talking against the law, and what is more, they know it. There is absolutely no opportunity for them to fight in such States.

Then Mr. Corbett came home from England to announce that there wasn't any money in England anyway, and the fight must come off in the United States, both Florida and Louisiana, the only States where prize fighting is permitted, being barred. Mr. Jackson promptly proclaimed upon the landing of Mr. Corbett that he was waiting in Chicago, ready to sign the articles of agreement. Mr. Corbett declared that, being champion, it was not his place to wait upon Mr. Jackson's place to wait upon him, and that if there were to be any articles of agreement signed the process must be gone through with in New York. 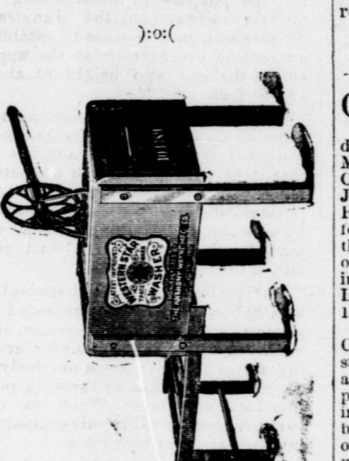
COURT PROCLAMATION.
