how natural to infer that he would not disdain to dwell in a temple erected by His servants, and that temple raised by David's son remains for ages the centre of the nation's religious life, although there were synagogues in all the cities of Palestine, to which the people resorted for prayer, and the hearing of the word of God, yet it was only in the temple of Jerusalem that sacrifice was offered. During the paschal season it was estimated that between two and three millions of people came in from the surrounding country to perform their religious duties. You see what sacrifice the people made in those days for the preservation of their faith and what a heavy yoke was laid upon them. But, at one of their great celebrations in the temple a youth of twelve years stood for the first time in their midst whose divine mission it was to lessen this heavy burden, to lighten this galling yoke. By His will and enactment that one temple of sacrifice at Jerusalem would be replaced by millions of temples erected in the



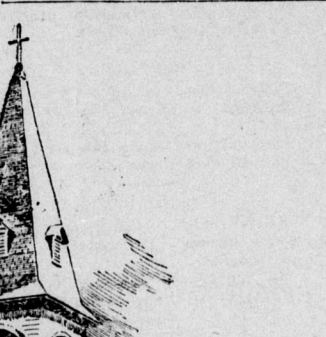

valleys and on the hill tops, not from the one true fold of Jesus Christ. In comparison with such a misfortune, so frequent with its eternal consequences, how trivial seems life's trials and burdens. This faith which is the most precious inheritance we have received from our

forefathers, is strengthened by the practice of virtue and weakened by the vices. It is written: "The just man liveth by faith, and his faith is the principle and source of his justification, leading him on from virtue to virtue till he arrives at last the fullness of perfect man." On the other hand, the passions by perverting sound reason and corrupting the heart, undermine the foundation of the spiritual life till at length the whole edifice collapses in utter ruin. Here Sunday after Sunday the death of the Lord shall be shown forth in your midst. Here the body that was broken and the Blood that was shed for us, shall be lifted before your eyes drawing you nearer, I trust, to that Savior in the bonds of love, and causing your lips to reach the glad cry of greeting with which of old they welcomed David's Son to earthy Zion—"Hosanna to the Son of David. Blessed is he that cometh in the name of the Lord. Hosanna in Excelsis." Where two or three are gathered together in my name there am I in their midst."

[We regret that lack of space prevents our printing Father Garvey's sermon in full.] At the conclusion of the sermon the Rev. speaker paid a well deserved tribute of praise to the Rector and his flock praying that God might spare them long years in peace and harmony and that they might enjoy the graces and blessings promised by Almighty God to those who loved and served Him faithfully.

Catholic faith from the hearts of the English people, it will make head way slowly, almost imperceptible, for the kingdom of Satan cometh not by observation any more than does the kingdom of God. Daily prayers will be forgotten, mass and the sacraments will be neglected, at first with a certain degree of compunction but as the years pass by with lessening qualms of conscience Christ says: "Whoever is not with me is against me, and whosoever gathereth not with me, scattereth." Experience proves the truth of those words, for these persons whom I have been describing gradually become embittered against the church. They hate her because she denounces them, and will not suffer them to pursue their evil way in peace. They descend mock upon the mercy of God and man's weakness but they make no account of the justice of God nor do they believe in the grace of God as a remedy for human frailty. Such persons may not become affiliated with any of the religious sects around us, but all the same they are outside of the pale of the Catholic church, and I ask you whether there can be any greater sorrow in this world to pious christian parents than seeing their children voluntary outcasts



FATHER ENRIGHT.

This sketch would be incomplete without a reference to the pastor who has labored so ardently and zealously in the erection of this church.

Rev. J. A. Enright was born in Alleghany N. Y., on June 7, 1863. His preparatory education was with the Sisters of St. Frances who conducted the Parochial School. At the age of sixteen he entered St. Bonaventure's College and Seminary, graduating four years later. Immediately afterwards he entered the Seminary conducted by the same faculty, where he made his Philosophical and Theological course and was ordained to the holy priesthood on August 24th, 1886 at Scranton by Rev. William O'Hara, D. D. Bishop of that Diocese. After sometime spent in the Cathedral he was sent to Dushore where he remained as assistant for four years, from there he was sent to St. Patrick's church in Scranton where he remained two years. Then the Dushore Parish was divided and Father Enright was sent back to take charge of the new Parish which comprises Bernice, Laporte, and Lopez. During his stay of four years in Dushore, Father Enright made hosts of friends, not only in that locality, but in the outside missions, a portion of which now com-

At 2 o'clock in the afternoon the sacrament of Confirmation was administered by the Rt. Rev. Bishop on a class numbering 127. The boys had in black and the girls attired in white wearing long veils and wreaths presented a beautiful sight, as they marched to the altar two by two to receive the sacrament at the hands of the venerable bishop, and took occasion to remind them in the following words of the great graces they were about to receive:

My Dear Children:—You have received in the sacrament of baptism the first and most necessary sacrament: God the Holy Ghost is to come to you again, today, in a special manner in the sacrament of Confirmation. Our blessed Lord was not only pleased to make you children of God, and heirs to the Kingdom of Heaven, but he desires to give you the special graces to-day which will make you strong and perfect christians. In baptism we receive our spiritual birth, but in confirmation we receive what is styled our spiritual manhood. It better enables us to observe the law of God and to keep the graces which we received in the sacrament of baptism. When you receive this sacrament, the Holy Ghost is sent upon you to sanctify your souls and your hearts and to make your bodies his abiding place forever. Then the Bishop, assisted by Rev. Millan and Father Enright, administered the sacrament, and at the close of the ceremony he reminded the children in a loving kind and paternal manner, exhorting them to preserve the purity of their lives, and in order to accomplish this, to shun all evil companions and dangerous occasions, and to practice in all its fullness all the teachings of the holy religion. Nor did he forget to remind their parents of their duty in looking after the spiritual welfare of their children, whom God had given to them as a special legacy.

After the ceremony had concluded the people adjourned to the Lakeside and spent the remainder of the day in secular enjoyment.
