fronted Wm. Penn in connection with his Province was the Indian trade; the western boundary of which according to the grant of the crown of England was five degrees 300 miles west of the Delaware. France at that time claimed all the lands the drainage of which came either to the Mississippi or St. Lawrence

rivers and in addition to the right of soil was that of the exclusive right to the trade with the Indians occupying the same, and in order to es tablish their claim and show proof of the same, buried leaden plates in the earth with inscriptions certifying election.

their object on the other hand. The English asserted their right to the trade of the tribes of those who by treaty had become the sub-

jects of the King of England. The Iroquoi nations were the controlling power on the Susquehanna at this time having taken the country by conquest and resided principaly in New York they first had entered in to a treaty of allegance to the Dutch and when that nation was superceded by the English they bound themselves to allegance to the crown of England. The Delawares and other nations entered into separate treaties with the English but were subordinate to the Iroquois, A small rem-

nant of the original Susquehanna tribe afterwards known as Conestogas not controlled by the Iriquos at the time of the settlement of Penn-




