crumbling effects of half a century of free trade. Our longest protective period was from 1861 to 1894, and although it was adversely affected by changing the wool schedule in 1883, yet in the main the country prospered and made great strides as a commercial nation. During that period the protectionists themselves lowered the tariff on many articles, as, for instance, the duty on steel rails has been reduced from \$28 a ton imposed in 1870.

to \$7.84 a ton, the rate in the Dingley law. The duty on tin plates imposed by the McKinley law was 2 2-10 cents per pound, and with that duty the industry got such a start that the duty was reduced to 1 1/2 cents a pound in the Dingley law. Many articles were transferred to the free list in both the McKinley and Dingley laws.

It is not inconsistent with good protection doctrine to reduce a duty or abolish it altogether if it is no longer needed, but it must be remembered that tariff laws are made primarily for revenue and the state of the public treasury may necessitate changes.

Our internal revenue laws furnish a splendid medium for such changes without disturbing our tariff, and in time of peace our revenue can be increased or diminished to the extent of \$100,000,000 without in any way disturbing business. But with the tariff it is altogether different. Even the possibility of a change of import duties causes apprehension, while the probability and afterward the actuality create havoc and panic. Importers and manufacturers must rearrange prices and wages to suit the changed conditions, for commerce is conducted for profit, not sentiment or philanthropy. When the manufacturer finds he must sell his goods in competition with foreign made goods, he must at once arrange for a reduction in expenses. Labor cost is the first and greatest thing to be considered, and the farseeing man knows that when wages are lowered there will be less of his product purchased, and he must curtail his production. The effect is felt everywhere at once, and it soon reaches the farmer, and his prices, too, must fall, and even then he may not dispose of his crop, and so consternation falls on farm and factory alike, and hard times are known from one end of the country to the other. This has always been the effect of tariff reduction or the probability of repealing protective duties.

And the reverse has always been true when low duties were to be increased. The business man does not wait till the signing of a tariff law before making his plans and adopting his changes. He anticipates everything months in advance. There is nothing that so disturbs business, that so frightens capital and unsettles labor as tariff changes and their anticipation.
