Local and Personal Events

The ladies of the Dushore Lutheran Church cleared over \$100.00 on Memorial Day serving warm meals to the visitors in town.

Charles Perry of Nordmont was transacting business at the county seat Wednesday.

Overseers of the Poor of Davidson Township, George Kiess and Wm. Robbins, were counseling with their attorney, A. J. Bradley at his Laporte office on Tuesday.

The ladies of the society of St. John's Guild, will repeat the minstrel show of a season ago, with selections from the opera of "The Mikado," at the Court House, Laporte, Pa., June 29, 1904.

A law suit involving Myra Lewis as plaintiff and Aaron Lewis as defendant came before Squire Keeler's court Tuesday which resulted in a decision favorable to the defendant. This litigation was brought on through the loan of a sum of money which became entangled with misunderstanding and law complications as money often does when out on loans.

Weather prophet, Emmor K. Sutter of Media, Pa., whose prophecy for May 19th came true in the shape of a frost in various section of the State, has another venture to make, a little further ahead. He says that he is positive that there will be another frost on June 13th, when the moon again changes "in the sign of the neck." He does not claim to have fore-knowledge of the velocity of the wind, and admits that his frost may miscarry or be made of little effect from that cause.

Two more heathen foreigners of Bernice were recently brought to the county seat and placed in jail to await trial, charged with assault and intent to kill one of their own tribe. With this depraved element engaged in mining at Bernice, Sullivan county will have to increase its jail capacity and mortgage all its assets to defray the constantly increasing expenses created by the lawless element brought in the county to add wealth to mine operators.

There has been an invention by which it will be possible to cross the Atlantic Ocean in three days, is the firm belief of Richard B. Painter a machinist of Williamsport. The machinery will all be run by electricity. Arrangements are now being made for the building of a large steamer at New York, measuring six hundred feet, on which the invention will first be tried.

The Department of Public Instruction has complied the apportionment to the various school districts of the appropriation to the school fund for this year and will on the first Monday of June begin the payment of the funds. To the regular appropriation is added this year to the last quarter of the special appropriation of \$1,000,000 made by the last Legislature to replace that amount deducted from the fund by Governor Stone.

The total amount to be paid this year will be \$5,442,552.26 and it has been apportioned according to the to the returns of taxable teachers and children between the ages of six and sixteen years in each district.

At a meeting of State Live Stock Sanitary Board held on May 21, reports were received relative to the investigation which is being conducted by the board for the protection of cattle from tuberculosis by vaccination.

State Veterinarian Dr. Leonard Pearson and Dr. S. H. Gilland have been conducting experiments in the endeavor to ascertain whether cattle can be immuned from the disease by means of vaccination. These experiments have developed the fact that vaccinated cattle exposed for a year to daily contact with animals effected with the disease did not contract it while those which had not been vaccinated readily became affected.

Calves of infected cows are now being vaccinated and left with their diseased mothers. They are allowed to use the parent milk for the purpose of ascertaining whether vaccination will approve affective under these conditions. It is generally conceded that unvaccinated calves raised with cattle infected with tuberculosis contract the disease.

The public school teachers' minimum salary law, enacted by the last legislature, goes into effect on the first of June next. A thorough canvass of every county in the state shows that 3,800 school teachers, over nine-tenth of them women, will receive substantial increase in salary during the coming term as the result of the operation of the law. Nearly \$750,000 as additional remuneration will be received by the teachers during the next term as the result of this increase. In nine-tenths of the districts there will be no increases of taxation on this account.

The law provides that after the first day of June, the minimum salary of the teachers shall be \$35 per month. It is made the duty of the president and secretary of each school district in the state, under oath to make report to the Superintendent of Public Instruction that the requirements of law have been fully complied with. The last section provides that "every school district of the commonwealth, failing to comply with the requirement of this act, shall forfeit its state appropriation for the whole time during which this act has been violated.

A western man was recently tried for assault and battery with intent to kill. The state brought into court of the weapons used, a rail, ax, gun, a pair of tongs, saw and rifle. The defendant's counsel exhibited as the other man's weapons a scythe, pitchfork, pistol, dog, razor and hoe. The jury decided the case as follows: "We, the jury, would have given a dollar to have seen the fight."

Mr. Irvin Died in Williamsport.
Mr W. R. Irvin, the well-known temperance lecturer, and who has been heard in lectures several times in Laporte, was taken ill suddenly last Thursday, since which time his mind has been a blank.

While driving through wildwood cemetery seated in a buggy by the side of his wife, Mr. Irvin after an uncommonly long silence, jumped from the vehicle and without uttering a word, commenced to disrobe himself. His wife induced him to return to the buggy and drove home where with the assistance of some men who responded to her call, managed to get her husband into the house. Later he was taken to the hospital where it was found necessary to strap him to the bed to prevent him from doing injury to himself.
