Some one has figured out that comparing what we have paid out for naval purposes since 1801 with the value of American property gives an average naval tax of .00123 per cent. 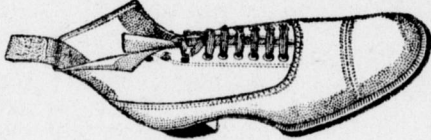
