Mrs. Lamellia Davis on Tuesday filed her statement in her suit for damages against the Williamsport and North Branch railroad, for the death of her husband, David Davis the engineer of the locomotive that blew up on October 6, 1905. Engineer Davis was killed in the explosion, and his widow asks for \$15,000 damages.

The Insurance adjusters met with the Laporte School Board Wednesday and settled the claim on the destroyed school building. The full rate of insurance \$3000 was allowed. At the present price of material it was figured to cost \$5000 to replace the same kind of building as was destroyed.

They are such immense concerns financially that they seemed to be able to stand any amount of stealing on the part of dishonest officials. Attorneys of Charles Johnson, convicted and sentenced to death for complicity in the murder of his brother's wife, Maggie B. Johnson, on September 17, 1904, made application for a change of venue, alleging prejudice and that Bigler Johnson, the woman's husband, before he was hanged in July for the same crime charged Charles with complicity and for the reason that the widespread publicity given the case has operated to create undue prejudice.

The court has granted a rule on the commonwealth to show a cause why a change of venue shall not be allowed.

Letters have been sent out by State Highway Commissioner Hunter to the county commissioners throughout the state, calling their attention to the provisions of the new road law, which makes it the duty of the commissioners to furnish the supervisors of each township, on the first Monday in March with the latest valuation of the township property for county purposes. It is on this valuation that the supervisors are authorized to levy the road tax for the ensuing year.

Kshinka, Associate Judge; Joseph Pennington, Court Crier; Josiah Hembury and Sargeant Fanning, Tipstaves, and A. J. Hackley, Janitor of the Court House.
