Houses to Be Erected.

A directors' meeting of the Lake Mokoma Company was held at Laporte Tuesday and Wednesday, attended by the following named officers: President, Chas. J. Pennock; Secretary, Edward S. Phillips; Thomas Rakestraw, J. B. Swayne, C. E. Cox, F. W. Meylert, W. C. Mason.

Considerable time was spent in going over the entire property \$10,000. making close inspection and deciding on improvements and the methods to be employed in executing the work

This pavilion will be open continuously throughout the

The other pavilion, 36x36, will be erected along the lake beach in which offices will be provided and also a confectionery stand. Sixty bath houses will be erected and three dozen row boats added to the
