Raises Passenger Rates. As a result of the decision of the Supreme Court of Pennsylvania, recently handed down, in the case of the Reading Railway against the County of Philadelphia, to enjoin the county from enforcing the two cent fare law of 1907, the Lehigh Valley Railroad Company is enabled to restore the passenger rates which prevailed on that line prior to October 1, 1907. The company complied with the 1907 law under protest, because of the large penalties which it would suffer for non compliance is case the law should be upheld.

Tariff schedules based upon the old passenger rates have been prepared and put into effect by the Lehigh Valley.


