Number One. A JOINT RESOLUTION

Proposing an amendment to section one, article eight of the Constitution of Pennsylvania. Be it resolved by the Senate and House of Representatives of the Com-monwealth of Pennsylvania in General Assembly met, That the following amendment to the Constitution of Pennsylvania be, and the same is hereby, proposed, in accordance with

which reads as follows: "Section 1. Every male cilizen twenty-one years of age, possessing the following qualifications, shall be entitled to vote at all elections, sub lect, however, to such laws requiring and regulating the registration of electors as the General Assembly may enupon act:

"First. He shall have been a citizen of the United States at least one month




