

Number Two.

A JOINT RESOLUTION Proposing an amendment to the Constitution of the Commonwealth of Pennsylvania so as to consolidate the courts of common -pleas of Philadelphia County.

Section 1. Be it resolved by the Senate and House of Representatives of the Commonwealth of Pennsylva-nia in General Assembly met, That the following amendment to the Constitution of Pennsylvania be, and the same is hereby, proposed, in accord-ance with the eighteenth article thereof :---

That section six of article five be amended so as to read as follows: Section 6. In the county of Philadelphia all the furisdiction and pow-ers now vested in the several numbered courts of common pleas of that county shall be vested in one court of common pleas, composed of all the judges in commission in anic courts. Such jurisdiction and pow-ers shall extend to all proceedings at law and in equity which shall have been instituted in the several num-bered courts, and shall be subject to such change as may be made by law and subject to change of venue as provided by law. The president judge of the said court shall be selected as provided by law. The number of judges in said court may be by law increased from time to time. This amendment shall take effect on the first day of January succeeding its adoption.

In the county of Allegheny all the jurisdiction and powers now vested in the several numbered courts of common pleas shall be vested in on court of common pleas, composed of all the judges in commission in sale courts. Such jurisdiction and power shall extend to all proceedings at law and in equity which shall have been instituted in the several numbered courts, and shall be subject to such change as may be made by law, and subject to change of venue as provid ed by law. The president judge of the said court shall be selected as provided by law. The number of judges in said court may be by lay increased from time to time. This Thi amendment shall take effect on the first day of January succeeding its adoption.

the said city an annual current nel The amount of such de revenue. duction shall be ascertained by cap italizing the annual net revenue from such improvement during the year immediately preceding the time of such ascertainment; and such capitalization shall be estimated by ascertaining the principal amoust which would yield such annual, current net revenue, at the average rate of interest, and sinking-fund charges payable upon the indebtedness is curred by said city for such pur poses, up to the time of such ascertainment. The method of determine ing such amount, so to be deducted may be prescribed by the General Assembly. In incurring indebted-ness for any purpose the city of Philadelphia may issue its obliga tions maturing not later than fifty (50) years from the date thereof, provision for a staking-fund with sufficient to retira said obligations at maturity, the payment to such sinking-fund to be in equal or graded annual or other periodical instal ments.
